Budget for 2014

The proposed 2015 budget was discussed and reviewed against the 2011, 2012, and 2013 actual expenses and the 2014 budget for this year. Discussion on each of the seven township funds followed.

The following items were noted:

- In past years the budget for supervisor and clerk wages did not include the amount contributed to the FSA as it has been paid from a separate account code. For clarity, the FSA deductions have been added to the budget item for supervisor and clerk wages in order to present a complete picture. Though no salary increases have occurred entering 2015 the budget line items appear higher than in the past due to this accounting change.
- The Treasurer was requested to look at the budget lines for election expenses and determine if they can be consolidated. Specifically look at combining 41535-354 with 41410-354.
- Verify that the township insurance for P&Z provides the maximum coverage.
- Add a budget item for receipt of permits and fees.
- Add a budget item account/code for general community support to replace the acct/obj code used for the cemetery contributions.
- Add a contract service line under acct. code 43560

Supervisor Heathman moved to approve the budget pending confirmation of the 2015 fire costs and the consolidation of election expenses. Second by Laures.
