2020 Year-in-Review:

- Planning Commission reviewed seven active Conditional Use Permits and approved three new CUPs and one new IUP. Details can be found on the website.
- Presidential Primary Election, Primary Election and General Election were held at the town hall. Thank you to all who served as election judges last year.
- Meetings were held in person and via the call-in option due to COVID-19 restrictions beginning in April.

Road maintenance and Snow Removal: Please help our road crew maintain and clear our roadways. **Place your trash containers at the end of your driveway off the road.** With an accumulation of more than 2 inches of snow, vehicles must be removed from the roadway. Thank you!

Storm Water Education: Report to Township Supervisors any illicit discharge and dumping in ditches to help prevent storm water pollution. We are required by state and federal law to establish programs and reporting mechanisms to reduce the discharge of non-storm water and pollutants into our waterways.
