2018 Year in Review:

- Planning Commission reviewed six active Conditional Use Permits. Details can be found on the website.
- Wilmar Investments, LLC v. Cascade Township was dismissed following the approval of CUP 18-01.
- Township picnic was held on August 23 at the Town Hall.
- Planning Commission and Town Board approved one new Conditional Use Permit.
- Dean Hegrenes joined the Township Board of Supervisors.

Road maintenance and Snow Removal: Please help our road crews maintain and clear our roadways. **Place your trash containers at the end of your driveway off the road.** With an accumulation of more than 2 inches of snow, vehicles must be removed from the roadway. Thank you!

Storm Water Education: Report to Township Supervisors any illicit discharge and dumping in ditches to help prevent storm water pollution. We are required by state and federal law to establish programs and reporting mechanisms to reduce the discharge of non-storm water and pollutants into our waterways.
