

Chesapeake Redevelopment and Housing Authority Board of Commissioners

The Chesapeake Redevelopment and Housing Authority Board of Commissioners consist of nine (9) members, one of whom serves as Resident Commissioner.

The members are appointed by the Chesapeake City Council and may serve up to two consecutive 4-year terms from the date of appointment.

The Commissioners are the governing officers of the Authority. Their responsibilities include setting policies governing the operations of the Authority, charting the direction of current and future programs and development, and approving contracts entered into by the Authority.

The Board of Commissioners hires the Executive Director, who serves as Board Secretary and is responsible for managing the Authority's day-to-

The Chesapeake Redevelopment and Housing Authority Board of Commissioners convene on the fourth Wednesday of each month, with the exception of November. Meetings begin at 5:00 p.m. and typically take place at the Authority's Administration Office located at 1468 South Military Highway in Chesapeake, Virginia.

Special meetings may occur at any time throughout the year. Special Meeting notices will be distributed at least five (5) days in advance should this occur.

Virginia Rent Relief Program

The Virginia Rent Relief Program (RRP) is designed to support and ensure housing stability across the commonwealth during the coronavirus pandemic. Depending on availability of funds and household need, the RRP may provide financial assistance for rent payments for eligible households. This includes financial assistance for rent payments past due beginning April 1, 2020 and onward with the opportunity for renewal based on availability of funding and the household's need for additional assistance and continued eligibility. This assistance does not have to be repaid.

Effective Dec. 1, 2021, RRP transitioned to a one-application system for both landlords and tenants to initiate and apply for rent relief. An updated, secure, and user-friendly portal known as Gov2Go allows you to access the Rent Relief Program on virtually any webenabled device. Assistance for tenants and landlords is also available by calling the RRP Support Center at 1-833-RENT-RELIEF (1-833-736-8735). Status on applications submitted through Gov2Go can be checked on the platform or by calling the Support Center.

Aspire360 Jobs Plus Initiative Program



Aspire360 Jobs Plus Program Kickoff

In January 2022, CRHA's Aspire360 Jobs Plus Program kicked off with approval of its six-month startup budget, four-year work plan and the hiring of essential staff to successfully launch the Jobs Plus program. The program is a four-year commitment. The immediate objectives involved marketing, recruitment and enrollment.

In February, Aspire360 established social media platforms to spread the word (<u>Facebook</u>, Instagram and TikTok) and staff began enrolling program participants following their assessments.

In March, the Jobs Plus team and community coaches created a newsletter, entitled "Aspire360 Buzz." The newsletter helps spread the word and get people involved in activities and programs, and creates effective communication throughout the communities. The newsletter includes activities for families and children. To date, twenty-nine (29) clients have been enrolled, assessed, and offered services. The first Quarterly Job Fair will be scheduled in the very near future.
