



Application for Minor Peddler's License

INSTRUCTIONS

APPLICANT:

- Complete the Peddler License Application and include the following attachments:
 - 2"x2" head-and-shoulders picture** (photo taken within 60 days of application)
 - \$24.00 NON-REFUNDABLE Application Fee** (cash, debit card, check or money order made payable to the "City of Troy")
 - State of Michigan Work Permit** (required)
 - Parent/Guardian Consent Form** (signed and notarized)
 - Food Truck Applicants** must provide:
 - Letter from property owner granting permission for food truck.
 - Address or location where food truck will be operating
- Submit the completed application to the City Clerk's Office

CITY CLERK'S OFFICE:

- Review accuracy of the completed application and attachments
- Obtain the applicant's fingerprint
- Process payment; print receipt for the applicant; write receipt info on bottom of application
- Route application electronically to approving department(s) for approval/denial

APPROVING DEPARTMENT(S):

- Reviews application and notifies City Clerk's office of approval/denial

CITY CLERK'S OFFICE:

- Denial - Notifies applicant
- Approval - Contacts applicant for length of license term desired, prepares license, and issues license with Do Not Knock info sheet upon receipt of Peddler's License fee.

APPLICANT:

- Peddler's License fee **MUST** be paid at the City Clerk's Office **before** peddling or operating food trucks may begin. ** The Peddler's License fees, payable at the time of issuance, are:

\$ 20.00 per week
\$ 40.00 per month
\$100.00 annually (expires 12/31 of each year).

**Chapter 74, Section 7, of the Troy City Code, states that "no person shall engage in the business of peddler without first obtaining a license therefore." Section 11 of Chapter 74, states "A copy of the permit or license must be carried by each solicitor or peddler. Solicitation or peddling without a valid permit or license or a copy of the permit or license is a misdemeanor, punishable by a fine of up to \$500.00, 90 days in jail, or both." Also, Section 20 of Chapter 74, states "No peddler or solicitor shall enter onto property which has posted a "No Solicitation" sign, or its equivalent, or whose address is at that time on the Do-Not-Knock Registry."

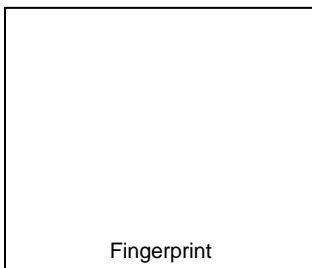
