TROY SIGN PERMIT PROCESS:

- Receive sign and if applicable, electrical permit.
- Construct the sign.
- Sidewalk inspection at City Hall
- Install sign. Footing inspection required for signs over 6 feet height.
- Final electrical inspection passes (energized signs only)
- Submit Certification Letter (where required).
- City approves Certification Letter.
- City schedules final Sign Permit Inspection.

 - HEIGHT FROM GRADE TO TOP OF SIGN
 - CONSTRUCTION METHOD AND MATERIALS
 - FOOTING DETAIL INCLUDING **DEPTH**
 - WIND LOAD CALCULATIONS *****UP TO 115 MPH WIND LOAD.*****

DIGITAL/ELECTRONIC MESSAGE SIGNS

ELECTRIFIED SIGNS – typical problems to avoid (not all inclusive)

- REQUIRED ONSITE, SIDEWALK INSPECTION OF UL LISTING AND MORE PRIOR TO INSTALLATION. EQUIPMENT MUST BE BROUGHT TO CITY HALL FOR INSPECTION. ADVANCE SCHEDULING REQUIRED.
- AN EXTERNAL DISCONNECT/SWITCH IS REQUIRED. SHALL NOT BE ATTACHED TO SIGN EQUIPMENT.
- PROVIDE CIRCUIT BREAKER LOCK, LOCKABLE IN THE OPEN POSITION, THAT REMAINS IN PLACE.
