

# **Cleveland City Council Meeting Minutes**

Monday, July 11, 2022 - 6:30 P.M. Cleveland Community Center/Police Department 342 Campbell Street, Cleveland, GA

#### 1. Call to Order

Mayor Turner called the meeting to order at 6:30 p.m.

#### PRESENT:

Mayor Josh Turner, Council Members Nan Bowen, Rebecca Yardley, Jeremy McClure, and C.J. McDonald (Mayor Pro Tem)

Also present were City Administrator Kevin Harris, City Attorney Grant Keene, and City Clerk Lisa Ritchie

Pastor Vargas stated that Basan Ministries has been in the City of Cleveland for approximately five years.

4. Approve Agenda

Motion by Council Member Yardley, seconded by Council Member McDonald and voted, unanimously, to approve the agenda with an amendment to remove item number 14 from the agenda.

# **PUBLIC HEARING**

5. November Referendum for the package sale of distilled spirits

Mayor Turner stated the following:

 Mayor and Council Members will hold two (2) Public Hearings on the question of whether the issuance of licenses for the package sale of distilled spirits in the City of Cleveland shall be permitted.

- o Monday, July 11, 2022 Meeting at 6:30 at the Cleveland Police Department
- Monday, July 25, 2022 Called Meeting at 6:30 at the Cleveland Police Department
- A copy of the proposed ballot question to be considered by the City Council is currently available for public inspection online as well as at Cleveland City Hall, Monday through Friday, from 8:00 a.m. to 5:00 p.m.
- O Under Senate Bill 145, the Georgia General Assembly and Governor Kemp revised the law allowing cities and counties to call for a ballot question on liquor package sales by resolution or ordinance. Under the previous law, the petition threshold of 35% of registered voter signatures was required to initiate the process. Under the law passed in 2021, 20% of registered voter signatures or a majority vote of the Council would allow a referendum to be placed on a ballot.
- The City Council wants to hear from its citizens prior to any potential vote taking place. For that purpose, the Cleveland City Council will hold two (2) Public Hearings on the question of whether the issuance of licenses for the package sale of distilled spirits in the City of Cleveland shall be permitted.
- The hearings have been publicized and printed as required by all city and state requirements.
- At the end of the hearing on Monday, July 25, 2022, there will be a time at the end to entertain motions on the topic from any member(s) of the city council.
- o If a motion were made in order, and received a majority vote, a distilled spirits referendum could be placed on the November ballot for city residents.
- o If the referendum is approved in November, the city would begin the process of developing ordinances to create the regulations and application process. The city would then set a date to complete the ordinances and determine when distilled spirits sales could begin.
- Public Comments may be provided at the meetings scheduled for July 11 or July 25 or by e-mail at <u>PublicComments@cityofclevelandga.org</u>.
- After the 2<sup>nd</sup> Public Hearing portion of the meeting on July 25, action may be taken by the Council regarding the call for a special election.

Mayor Turner asked that everyone abide by the Rules of Decorum that are in effect for this hearing and all Council meetings.

Mr. O'Bryant stated that he received an e-mail from Senator Warnock's Office Chief of Staff earlier in the day. They are sending their Chief of Staff on Friday, July 22<sup>nd</sup> to meet with Cleveland staff.

o Infrastructure – Phase 3 of the by-pass, GDOT redesigning infrastructure for the proposed bridge that will replace the collapsed culvert. Mr. O'Bryant stated that he is in discussions with the City Engineer on this item.

#### POLICE CHIEF JEFF SHOEMAKER

11. Request for the purchase of a 2022 Ford Explorer

Chief Shoemaker stated that the purchase would be funded by SPLOST.

Motion by Council Member McDonald, seconded by Council Member Yardley and voted, unanimously, to approve the purchase of a 2022 Ford Explorer from SPLOST funds.

## **CITY ADMINISTRATOR KEVIN HARRIS**

Mr. Harris reported the following items:

- Staff is working on metrics to make sure that the Mayor and Council have all the information they need to make decisions
- Staff is waiting for information from the Tax Commissioner for the scheduling of millage hearings
- Commendations to Public Works for working in the heat
- The personnel code was last updated in 1994. Staff will work on a comprehensive update, working on sections at a time. It should be complete by this time next year.

#### **CITY ATTORNEY GRANT KEENE**

Mr. Keene addressed the Mayor and Council Members. He announced his withdrawal as City Attorney at the end of the year. He expressed his appreciation for being allowed to serve for 33.5 years. He stated that the resignation is effective at the end of the year. He also offered to serve in an amended capacity through the end of the year.

On behalf of the City Council and City Councils' past, Mayor Turner expressed appreciation for Mr. Keene's service and counsel to the City of Cleveland. Mayor Turner stated that they recognize his professional abilities and his courteous and professional behavior.

Mr. Keene received a standing ovation.

#### **NEW BUSINESS**

Mayor Turner stated that Mr. Keene has been communicating his plans to resign at the end of the year. He said the Mayor and Council have been interviewing candidates to fill Mr. Keene's position. He said it was a difficult task with Mr. Keene serving for 33.5 years.

Motion by Council Member Yardley, seconded by Council Member McClure and voted, unanimously, to approve the engagement of professional services with Keith J. Whitaker and Smith Gilliam Williams and Miles.

Mr. Whitaker addressed the Mayor and Council members. He said he is a lifelong resident of Cleveland and looks forward to working with the Mayor and Council and with Mr. Keene.
