Called Meeting Minutes**

1. Call to Order

Mayor Turner called the meeting to order at 9:00 a.m.

Motion by Council Member McClure, seconded by Council Member Yardley, and voted, unanimously, to approve the agenda.

Mayor Turner welcomed the public and expressed his appreciation for their attendance at the 2nd of 3 millage hearings. He stated the purpose of the hearings is to set a millage rate for Cleveland. Mayor Turner said the starting point of 5.472 mills would lower the millage by .446 mills from 5.918 mills.





Mr. Harris restated the current, advertised, proposal of 5.472 mills which is a partial rollback.
