CALLED CITY COUNCIL MEETING

The Called City Council Meeting of the Mayor and Council of the City of Cleveland was called to order by Mayor Pro Tem Kevin Stanley at 9:00 a.m.

COUNCIL PRESENT: Nan Bowen, Kevin Stanley, and Bradley Greene

APPROVAL OF AGENDA

On motion by Nan Bowen, seconded by Bradley Greene, and carried unanimously, the Mayor Pro Tem and City Council voted to approve the Called City Council Meeting agenda of June 25, 2020.

Review and approval of liability insurance for 2020/2021

APEX liability insurance quote - General Liability, Police Professional Liability, Public Officials, Employment Practices, Cyber Liability, Automobile Liability, Crime, Property, Flood/Earthquake, Inland Marine, Umbrella, and Terrorism - \$87,877.00

The purpose of the Called City Council Meeting is to approve the quote for city liability insurance for the 2020/2021 budget year.

Tom O'Bryant reviewed the plan with the City Council:

- a. The 2020/2021 liability insurance has been provided by Kern Parks, Norton Insurance.
- b. The company sends the city's policy out for bid to obtain the best quote
- c. The city's current provider, Selective Insurance, contract is set to expire June 30, 2020. Selective has proposed to increase the city's premium to \$109,290.
- d. Bids came in and Apex Liability Insurance provided a bid of \$87,877. This includes general liability, police professional liability, public official, employment practices, cyber liability, automobile liability, crime, property, flood/earthquake, inland marine, terrorism, and umbrella.
- e. The bid is within the budget set for FY21.
- f. Staff recommends the City Council approval of the APEX liability for Insurance for FY21.

Mr. O'Bryant added the reduction in the cost of the plan will allow the city to add equipment or to the policy throughout the budget year.

On motion by Bradley Greene, seconded by Nan Bowen, and carried unanimously, the Mayor Pro Tem and City Council voted to approve the insurance bid from Apex Liability Insurance for 2020/2021 in the amount of \$87,877.
