A RESOLUTION TO AMEND THE CITY OF CLEVELAND, GEORGIA FEE SCHEDULE SOLID WASTE ORDINANCE 2020-14

WHEREAS, the Mayor and Council of the City of Cleveland desire to amend the Solid Waste Ordinance of the City of Cleveland so as to revise **Chapter 24 - Fees, Fines and Other Charges** schedule of fees, for the years 2020, 2021, and 2022, to be charged for collection and disposal of solid waste within the City of Cleveland; to provide an effective date; to repeal conflicting ordinances or parts of ordinances; and for other purposes.

NOW, THEREFORE, BE IT RESOLVED by the Cleveland City Council, that the Solid Waste Ordinance of the City of Cleveland so as to revise **Chapter 24 - Fees, Fines and Other Charges** is hereby amended as follows:

SECTION I. FEES
