Hello Neighbors,

How can it be Autumn already? Is it just me, or do you feel that time passes faster and faster each year? I hope you all were able to get out and enjoy the beautiful Walla Walla Valley, even if it was simply watching some of our amazing summer sunsets. In the evening time, one of my favorite things to do is to just sit and listen to the crickets' chirp and the frogs croak while looking up towards the limitless night sky. I have no doubt a few of you have joined me a time or two.

Along with the cooler weather, this time of year brings us darker days just as our children are returning to school. Please remember to drive safely, slow down, and watch out for school buses and parents dropping off students, along with your neighbors who are out doing life.

There is nothing more important than a life, nothing. Let's follow the motto of 'College Place Cares' and be considerate neighbors.

I am excited to share that College Place has once again been awarded a grant for some muchneeded infrastructure improvements. In September, we were awarded \$341,184 from WA
State Department of Commerce for our SafeWalk College Place Project, which allow us to construct sidewalks between SW 6th (College to Davis) and SW 8th (College to Bade). So far in
2021, we have saved College Place taxpayers over \$1 million dollars while still getting vital safety and beautification improvement projects done. Getting these grants is not easy, they are
extremely competitive, and require compelling assurance that funds will be properly used.
They come with restrictions and requirements and can be very time consuming. I am grateful
to our amazing City Administrator, Mike Rizzitiello, Finance Director, Brian Carleton, and

Community Development Director, Jon Rickard for their ability to take an idea (sometimes I can come up with doozies) and make them into realities, all while finding money to pay for them all. There is no better team than our city staff!

I would like to briefly address the topic of elections. This year is an election year here in College Place, which I imagine you already know by the appearance of campaign signs. I want to remind the good people of College Place that a vital part of our country's democracy is a free and fair election process. That includes respecting the efforts of candidates to bring awareness to their campaign. I am disappointed that there have been several reports of vandalism to signs and banners in our city. There are laws that protect our rights to campaign, that includes placing signs on public right of ways and private properties (with the owner's consent, of course). Removing or damaging campaign signs is a misdemeanor offense, so please, let us respect our election processes. Instead, show your support on the ballot.

Did you know that the City takes your average water usage in the winter months to determine your sewer flow cap for the remainder of the year? We do this to help make sure your utility bill doesn't sky rocket in the summer due to sewer usage. We take that average in the winter as the amount of water you use inside the house (when you aren't watering your lawn or garden). This helps us determine the amount of extra water you use in the summer isn't going into the sewer, so you don't get charged for it. We begin that winter average calculation in December with the final read in February. You will see that new winter average cap take effect in March. If you have any questions or you find out that you have a leak, please contact the Utility Clerk at 509-529-1200.
