A Message From The Mayor

Hello Neighbors,

I sit here in my makeshift office at home, which is just an extension of my kitchen, looking out my window hoping to catch a hummingbird make use of one of the many feeders I have in my back yard. During the freezing temperatures, I was diligent about rotating feeders every hour or so to keep liquefied man-made nectar in the feeders, but so far, I have not been given the pleasure of a witnessing a single hummingbird enjoying some sweetness at my window.

However, I take solace in all the other birds who visit daily to enjoy some seeds and give my two cats some theater style entertainment. I also recently added a few bird houses to the yard, hoping to give some of our bird friends some shelter from the cold, and I must admit, I am getting obsessed with wanting birds to habitat them. I was shopping for bird box cameras so that I might know when I have new neighbors, but have not found the right one yet. Do not worry Jim & Sheri and Steve & Glady's your privacy will be well respected-unlike our feathered neighbors, by me.

I would like to use the rest of this letter to discuss the fast-approaching Special Election on February 8th. There is only one item on the ballot, College Place School District's Proposition 1, which is a replacement of the expiring Educational Programs and Operations Levy (EP&O). I will not tell you how to vote, but I do want to do what I can to help you know exactly what the EP&O Levy is and is not about and the consequences of your vote.

In the past, CPPS had two separate levies, however this year they have combined it into one single and simple levy. First, this levy is about a commitment by the voters of our wonderful city to support our children's access to education and extra-curricular mind and body strengthening activities for four years. The proposed 2022 EP&O Levy replaces the two levies that were approved in 2018, however, this one will cost less, while still maintaining the programs that have been supported by the last levy. This levy has built it limitations that will protect property owners from unexpected tax increase surprises. For example, there is a maximum of \$2.50 per \$1,000 assessed value, which is \$0.10 less than the levy expiring at the end of this year. Additionally, there is a total collection ceiling of \$18.9 million that is allowed to be collected between the years of 2023-2026, which will again be broken down by each year. That means, the levy will not be able to collect more no matter what property values go up to. Property owners are assured of collection caps. In fact, the opposite could happen, property owners may actually see a rate lower than the \$2.50 calculated.

Secondly, I know many of us believe that supporting our schools and our children's public education belongs to the state, which already collects taxes from us. While there are some truths to that, it is not so clear cut. The state gives CPPS only the minimum needed to give basic education to students. That's basic reading, writing, arithmetic, science, and history. "Basic" being the key word. The district must collect funds on their own to provide our children with classroom para-educators, nursing, counselors, social & emotional support services, special education services, buses (no, the state does not give money to get children to school or activities), STEM, smaller class sizes, and one-to-one technology devices (I cannot even imagine how much worse our students would have been without district provided Chrome tablets for students to use at home during the long pandemic caused school closures!), everything that is required in order to teach our kids vital thinking and problem solving skills.

Furthermore, the EP&O Levy will fund athletics, vocational programs, the arts-such as band, choir, and drama; intervention services and staffing, the on-campus school resource officer (providing physical safety to our kids), and believe it or not, even utilities, maintenance, and operation expenses. Shocking, is it not?

I know that all of us are tax fatigued and that adding more to is not exactly enticing. Please know, this is <u>not</u> a new or additional tax. It is a continuation of what we already pay and at a lower dollar amount than the last four years. We also cannot afford to risk what will become of our children should they only be given "basic" education with no ability to exercise, learn competitive teamwork, to obtain leadership skills, confidence, and fall behind the world due to lack of technology. The state will not make up for any gaps, they will not come to our community's rescue with money for our schools. This is all up to us and us only.

This is not about politics either. No matter who is in the White House or in Olympia, it would still be the same situation. Our kids, their futures, do not deserve to be pawns in political chest pounding games that are not even relevant to their education and social growth. We live in a different world than we grew up in, basic education is not what America's children need to be competitive in our global system. And although I have no kin attending any College Place Public Schools, I will happily invest in the future of someone else's who one day, will be the person making decisions for my future.
