A RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH  
RIO SUPPLY, INC. SICKLERVILLE, NEW JERSEY  
FOR THE PURCHASE OF WATER METERS

WHEREAS, there exists a need to purchase additional water meters in connection with the final phase of replacing water meters throughout the Borough; and

WHEREAS, the Borough of Collingswood solicited bids for the Supply of Water Meters through an advertisement on October 7, 2022; and

WHEREAS, On October 18, 2022 at 11am, the Borough of Collingswood received, opened and read aloud in public the one Bid which was received; and

WHEREAS, after review of the bid document submitted, the Qualified Purchasing Agent recommends awarding a contract to Rio Supply 100 Allied Parkway, Sicklerville, NJ 08081 for the purchase of Water Meters; and

WHEREAS, the Chief Finance Officer hereby certifies that funds will be available in the following Water Utility Budgets:

2023 - 3-05-26-828-156 not to exceed \$175,300.00;

2024 - 4-05-26-828-156 not to exceed \$188,010.00; and

2025 - 5-05-26-828-156 not to exceed \$201,575.00.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Commissioners to enter into an agreement with Rio Supply, 100 Allied Parkway, Sicklerville, NJ 08081 for the purchase of Water Meters as needed.
