AN ORDINANCE ADOPTING AN AMENDMENT TO THE REDEVELOPMENT PLAN FOR THE BOROUGH OF COLLINGSWOOD, COUNTY OF CAMDEN, STATE OF NEW JERSEY

WHEREAS, the Board of Commissioners of the Borough of Collingswood (the "Commissioners"), adopted Resolution No. 06-186 which designated the entirety of the Borough as an "Area in Need of Rehabilitation" pursuant to the Local Redevelopment and Housing Law (the "Redevelopment Law"), N.J.S.A. 40A:12A-1 et seq.; and

WHEREAS, pursuant to N.J.S.A. 40A:12A-7, a Governing Body may adopt, revise or amend a redevelopment plan; and

WHEREAS, pursuant to Ordinance No. 1417, the Borough Commissioners adopted a redevelopment plan for the entirety of the Borough entitled "Plan for Rehabilitation, November 2006" (the "Redevelopment Plan"), which adopted the underlying zoning then in effect throughout the Borough of Collingswood, subject to certain exceptions; and

WHEREAS, pursuant to Ordinance No. 1664, adopted on June 3, 2019 the Borough Commissioners amended and replaced the original Redevelopment Plan in its entirety; and

WHEREAS, pursuant to Ordinance No. 1718, the Board of Commissioners adopted a Restated and Amended Redevelopment Plan (continued to be referred to as the "Redevelopment Plan"); and

WHEREAS, the Mayor and Commissioners have determined to amend the Redevelopment Plan to promote the rehabilitation of the property located at Block 22, Lot 13 more commonly known as 627 Haddon Avenue (the "Property").

NOW THEREFORE, BE IT ORDAINED, by the Board of Commissioners of the Borough of Collingswood, in the County of Camden, State of New Jersey, that the Borough Redevelopment Plan as it pertains only to the Property is hereby amended as follows:

A. Permitted Uses

To support the goals and objectives of this Redevelopment Plan, only the following uses shall be permitted on the Property. Uses not specifically identified in this Redevelopment Plan as a permitted principal or accessory uses as it relates to the Property shall be prohibited.

- (1) All uses permitted in the Central Business District (CBD)
- (2) Mixed uses comprised of those permitted in the Central Business District (CBD)

B. Permitted accessory uses shall be as follows:

(1) Those indicated in the Central Business District (CBD)

C. Conditional uses shall be as follows:

(1) Those indicated in the Central Business District (CBD)

D. Area and Bulk Requirements

Principal Building Setback	
Front Yard	0 feet
Rear Yard	10 feet
Side Yard	0 feet
Maximum Building Coverage	60%
Maximum Impervious Coverage	96%
Maximum Building Height	45 feet

E. Parking

- 1. On-site parking is not required for principal permitted uses.
- 2. Accessory residential uses shall provide parking as follows:

a. 1-bedroom unit: 1 space per unitb. 2-bedroom unit: 1.5 spaces per unit

- 3. Where practical, efforts should be made to provide screening and robust landscaping.
- 4. One-way drive aisles, where 45-degree parking is provided, can be 13 ft.

Section 2. The Commissioners have determined that the amendment to the Redevelopment Plan satisfies the criteria, guidelines and conditions set forth in N.J.S.A. 40A:12A-7, provides realistic opportunities for redevelopment of the Rehabilitation Area and is otherwise in conformance with N.J.S.A. 40A:12A-1, et seq.

Section 3. The Commissioners also have determined the amendment to the Redevelopment Plan is consistent with the Borough's Master Plan.

Section 4. The amendment to the Redevelopment Plan shall constitute an overlay zone to the extent set forth therein.

Section 5. This ordinance shall take effect after final adoption and publication according to law.

WHEREAS, pursuant to Ordinance No. 1664, adopted on June 3, 2019 the Borough Commissioners amended and replaced the original Redevelopment Plan in its entirety; and

WHEREAS, pursuant to Ordinance No. 1718, the Board of Commissioners adopted a Restated and Amended Redevelopment Plan (continued to be referred to as the "Redevelopment Plan"); and

WHEREAS, the Mayor and Commissioners have determined to amend the Redevelopment Plan to promote the rehabilitation of the property located at Block 95, Lots 24, 25 and 26 more commonly known as 16, 20, 24 W. Collings Avenue (the "Property").

NOW THEREFORE, BE IT ORDAINED, by the Board of Commissioners of the Borough of Collingswood, in the County of Camden, State of New Jersey, that the Borough Redevelopment Plan as it pertains only to the Property is hereby amended as follows:

A. Definitions

Cigar lounge

An establishment designed specifically for the smoking of tobacco products purchased on premises. The consumption of products purchased on site, may occur either indoor or outdoor, but must take place in a designated area with adequate ventilation. A cigar lounge may serve food or alcohol as an accessory use.

Banquet Hall

A large room or building designed to host formal gatherings, especially those involving a meal and other events. It's commonly used for weddings, receptions, corporate events, and other social gatherings that require seating for a large number of people.

B. Permitted Uses

To support the goals and objectives of this Redevelopment Plan, only the following uses shall be permitted on the Property. Uses not specifically identified in this Redevelopment Plan as a permitted principal or accessory uses as it relates to the Property shall be prohibited.

- (1) All uses permitted in the underlying zone
- (2) Any preexisting nonconforming use
- (3) Cigar lounge
- (4) Banquet hall
- (5) Mixed uses comprised of those indicated above

C. Parking

So long as the existing fire station building is not expanded, onsite parking is not required.

Section 2. The Commissioners have determined that the amendment to the Redevelopment Plan satisfies the criteria, guidelines and conditions set forth in N.J.S.A. 40A:12A-7, provides realistic opportunities for redevelopment of the Rehabilitation Area and is otherwise in conformance with N.J.S.A. 40A:12A-1, et seq.

Section 3. The Commissioners also have determined the amendment to the Redevelopment Plan is consistent with the Borough's Master Plan.

Section 4. The amendment to the Redevelopment Plan shall constitute an overlay zone to the extent set forth therein.

Section 5. This ordinance shall take effect after final adoption and publication according to law.

SECTION 1. The Borough Commissioners of the Borough of Collingswood hereby authorizes the following General Capital improvement to be funded from the General Capital Improvement Fund \$165,000:

- A. Construction of a Salt Storage Building \$115,000.00 B. Completion of Pocket Park \$50,000.00

The useful life of this equipment is at least five (5) years. No Supplemental Debt Statement is required since there is no authorization of any debt within this Capital Ordinance. The gross debt of the Municipality as defined by law is not increased by this ordinance, and no obligation in the matter of bonds or notes are authorized by this ordinance.

SECTION 2. The capital budget is hereby amended to conform with the provisions of this ordinance.

SECTION 3. This Capital Ordinance shall take effect immediately after publication following the final adoption as provided by law.
