TO WHOM IT MAY CONCERN:

As I stated in a previous letter, and as many others have stated, the problem with Mr. Adams' proposal is that it is incomplete and half-baked. One does not begin mining operations in a river without the proper agencies studying the issue to see what impact it will have on the environment, both the eco-system and the human element. Many of these agencies have extended a hand to Mr. Adams to work with him to try to find solutions to the problems affecting Pistol River. Why Mr. Adams has rejected input from these agencies is beyond me, but it reeks of profiteering more than concern for the environment. I found it interesting that TideWater has purchased the land right across the street from Mr. Adams proposed scalping operation.

Something else that came up (for the first time) in the November 20, 2019 Board Meeting, was the existence of "structures" that Mr. Adams swears "are working" to help the river. Upon investigating which structures he meant, I learned that these were a "fish hatchery" installed by a resident, Mr. Crook, without approval from the proper agencies. These concrete structures were leaching acid into the river and were ordered by the Department of Environmental Quality (DEQ) to be removed. Apparently, they were NOT fully removed, and now Mr. Adams wants to willy-nilly begin "scalping operations" because he believes he knows what's best for the river, without the benefit of collaboration with the proper agencies.

Finally, Mr. Adams expressed a great concern that the County was spending too much money

In regards to the application of Ron Adams, AD-1907, for removal of rock from the Pistol River at .2 mile from the mouth of river:

The major channel of the Pistol River has opened up after the rainfall of 11-19-2019. As the winter rains arrive, the channel will continue to widen and reshape the river. The properties upstream that have had erosion due to winter storms need to address that issue. In the case of a need of a local source of rocks for the Hooskanaden slide repair, there is a quarry source of rock on the Crook property in Pistol River. That rock has been used for work on several local driveways. The Crooks also have a rock crusher.

I am writing to you to urge that the Curry County Board of Commissioners **approve** the pending application filed by Ron Adams to remove gravel from the lower flood plain of Pistol River.

I am a resident of Pistol River with riverfront property (now technically owned by my son) that lies slightly upstream from the proposed gravel excavation area. My family has owned, farmed, and occupied this property since 1889.

I would like to advise you of several inaccuracies that have been publically disseminated regarding this application. The Curry Coastal Pilot in a front page story published on November 19, 2019 reported on a public meeting held November 14, 2019 at the Pistol River Friendship Hall. I attended that meeting. The article references a 2014 NOAA Fisheries document that cites "lack of floodplain and channel structure" as one of the "key limiting stresses for coho salmon recovery" in the Pistol River. I personally have a clear recollection of the river behavior during flooding events on Pistol River as well as a lifetime of observations of the salmon and steelhead populations that use this stream. I therefor believe that I can state with a high degree of certainty that:

- a) <u>The floodplain of Pistol River is at least as large now as it has historically been in the last</u> 75 years and exhibits much the same structure.
- b) <u>There is no present or historical record of which I am aware of a viable coho salmon</u> population in this stream. Stated another way, there is no physical or anecdotal evidence of which I am aware of a coho salmon run in Pistol River.

Reference is made in the Pilot article to the river historically having "20-foot deep pools and water too cold to swim in during the summer". That statement is incorrect. The pools in the lower 2½ miles of the river during my youth (1940's - 1950's) were approximately half that deep and we swam in the river every summer typically from early May through September just as my great-nephews do to this day.

Finally, the Pilot article stated "No one came to the meeting to support the proposal". That is also incorrect. In fact there were people attending that meeting who did support the proposal. No poll of the attendees or other measurement such as a show of hands to express support or disapproval was conducted.

I urge the board to base its decision on factual evidence and prevailing regulatory rules rather than on the myriad of half-truths and outright fabrications that always seem to accompany such proceedings.

There is general agreement that the estuary area in lower Pistol River has been the victim of heavy downward migration of gravel deposits. These gravel deposits are not the result of logging conducted upstream in the drainage basin but rather are the rearrangement of alluvial deposits that have been laid down over many centuries in the lower 2½ miles of the stream. The meandering of the lower reaches of Pistol River was interdicted in the early 1960's by the US Department of Agriculture through the Agricultural Stabilization and Conservation Service (ASCS) who developed a streambank protection



program on lower Pistol River in the form of rip-rapping of the river banks. This action effectively 'locked up' those ancient alluvial deposits of gravel and loam, allowed streamside riparian vegetation to thrive and develop, confined the stream to a more or less fixed channel, and promoted the beneficial use of streamside pastures for agricultural purposes.

The river remained stabilized in this state for a period of nearly 50 years at which point some of the weaker sections of rip rap began to deteriorate and required maintenance. Initially, one was able to attain permits to address the needed maintenance. However, after management of the stream became extremely sensitive to coho habitat protection, it became increasingly more difficult to obtain permit approval and perform any streambank protection activity especially below ordinary high water. Thus, the river successfully breached the rip rap, 'unlocked' the alluvial deposits and resumed the meander process. The net result was that hundreds of thousands of yards of alluvial material (predominantly gravel) along with the associated overstory of valuable riparian vegetation was transported downstream. The now useless riparian material in fact became a secondary problem when significant portions of the uprooted trees came to rest on the upstream edge of the concrete abutments supporting the Pistol River Loop Bridge.

In my opinion the current management regime of this stream for the benefit of an imaginary run of coho salmon has brought us to this condition and you are left with the consequences. You are now asked to determine if gravel can be removed from this site. If you deny this application you can expect that streamside conditions along this stream will continue to deteriorate. If you approve it you can expect some temporary improvement in keeping the river in its channel. The effect will probably be temporary since Pistol River has now resumed a meandering course and will continue to relocate alluvial gravel deposits and their corresponding riparian vegetation downstream unless and until it again becomes acceptable to protect the streambanks.

In conclusion, if the board collectively or any of its members wish to have an on the ground tour of the lower reaches of Pistol River and observe the conditions discussed above, I would be happy to host such an event.


Please **approve** the pending application filed by Ron Adams to remove gravel from the lower flood plain of Pistol River.

My husband and I have owned riverfront property on Pistol River since the early 1970's. His family had owned the property since the late 1880's. Thus we have had an excellent opportunity to observe this river for decades.

Many of the arguments opposing this application are shallow in that they merely repeat the 'advocacy rhetoric' that special interest groups roll out whenever natural resource decisions become necessary. An excellent example is the entire coho salmon charade. Coho salmon do not inhabit Pistol River.

I have seen printed and published literature citing a need to repair, restore and preserve Pistol River. Nowhere have I seen any specific mention of what kind of repairs need to be made to what, what are the specific items or conditions that we are being exhorted to restore, and what is the desired condition that we should be attempting to preserve. The only specific activity that comes close to addressing the issues of repair, restore and preserve that I have seen to date is the Ron Adams proposal for removing a portion of the gravel deposits that are destroying our estuary. The Adams proposal would at least to some degree relieve or repair the increasing gravel buildup in our estuary and would help in restoring the stream channel to a more stable and traditional route.

A deeper concern that I see is the alarming tendency of some to attempt to diminish the bundle of rights held by private property owners. Without any investment and no assumption of the burden of risk it is far too frequently that attempts are made to direct or control the legal activity of other private property owners on their own lands.

The Crook Family supports Ron Adams application for gravel removal from Pistol River. The river has lost its old channel and now has removed over 40 acres of bottom land during the last 30 years. This last year alone it took 10 acres of bottom land, reducing the area to gravel bar. Lands lost include part of an 120 year old orchard from the Crook Ranch, five acres of bottom land from the Larry Ismert property and five acres from the former Marion Walker property This is verified by reviewing photos of the river taken over the last 30 years.

We have discussed the river's huge gravel movement with the Oregon Fish and Wildlife employees and they have estimated that 40,000 yards of gravel moves down the river annually and 20,000 yards could be removed annually without detriment to the wildlife habitat.

Dear Curry County Board of Commissioners,

Oregon Coast Alliance is an Oregon nonprofit corporation whose mission is to protect coastal natural resources and work with coastal residents to enhance community livability. ORCA submits this additional testimony on the Ronald Adams proposal to mine gravel in the lower Pistol River region in order to respond to the latest submission from the applicant, recently made available to the public.

As stated in ORCA's prior testimony, the application and the appeal submissions suffer from basic lack of information, and complete failure to substantiate the allegations in support of the request. That the applicant's statements fail to fulfill the most basic requirements of Curry County ordinances is by now well documented in the record. The County requires the applicant to provide the County with sufficient information to determine whether the application meets relevant criteria on which a decision is based. In this matter, Mr. Adams' proposal continues to fail, on appeal as at the original planning commission application.

At the November 20th Board of Commissioners hearing on his appeal from the Planning Commission denial, however, Mr. Adams submitted a new packet of information (dated November 11, 2019), in which he has materially changed the proposal, substantially enlarging it from prior iterations. This packet includes a hand-drawn map that shows *four* gravel-mining sites on the Pistol. The similarly hand-drawn map submitted with Mr. Adams' initial appeal statement dated October 14, 2019, showed a single removal site.

The applicant brought this enormous expansion into the middle of the appeal proceedings with virtually no explanation other than a few unsubstantiated statements, but they made it clear the proposal is expanding in the applicant's mind: "[M]y plan is to remove the material from these four areas down to a depth which will be approximately two feet above the normal water level of the river, which will allow the normal hydraulics to work. The total amount of debris to be remove [sic] from these four areas will total approximately eight to ten thousand cubic yards if it was removed all in one year...The actual equipment used in the operation will be dump trucks and loaders that will be owned by private contractors. Any other equipment will more than likely, for short periods, be portable rock crushers."

Neither Curry County staff nor members of the public had seen this expanded proposal before Mr. Adams brought it to the November 20th appeal hearing. As this expansion is clearly not the original application submitted to Curry County, nor the one denied by the planning commission, the Board of Commissioners is justified in rejecting this expanded application as a new proposal, which would be subject to a separate permitting process, beginning with a complete application.

The *only* application before the Board of Commissioners is AD 19-07, the proposal submitted to Curry County by Ron Adams and denied by the planning commission. ORCA notes that Curry County should never have accepted this initial application as complete, as it contained none of the studies, information or even basic descriptions necessary for decision-makers to act. However, since the County did accept it, ORCA urges the Board of Commissioners to uphold the planning commission's denial of the request for all the reasons stated in our several testimonies before the planning commission.

The lower Pistol River is severely abraded, and continues eroding. A collaborative, focused restoration project honing in on the problems causing the erosion is needed. Indeed, the applicant himself is aware that his project will not solve the underlying problems, stating in his November 20th submission, "The sediment that we are planning to remove has been deposited here in the last three to four years...This will be replaced almost immediately by the abnormal transport of material that is upstream...We acknowledge that more keep coming..." In addition to any other reason to reject the application, the applicant *himself* acknowledges that the project is futile as a restorative action, even without scientific verification.

It is time to end this charade, whereby an incomplete application continues being heard, and changed, at every hearing opportunity. ORCA strongly recommends the Board of Commissioners deny the appeal, and begin working with community members, including Mr. Adams, on a solid, longterm plan to address the problems on the Pistol. Community members have already begun such a task, as testimony on this proposal indicates.

As noted, Mr. Adams' application is short on details and specifics and lacks evidence of any effort of coordination with the numerous governmental agencies.

My property is adjacent to the estuary down river from the 101 bridge and I don't feel Mr. Adams has sufficiently addressed the issues of dust, debris, noise and most importantly fish and wildlife habitat on the Pistol River.

Please deny the Adams application (AD-1907) for gravel extraction of the Pistol River.

After reviewing the materials submitted by Ron Adams at the11/20/19 hearing, I have even more concerns as he has expanded the proposed operation of gravel removal and processing at Pistol River. The number of sites/locations have gone from one or two to four. Attached you will find an image showing the locations as he defined in his maps as well as the proximity of sites to my residence as well as that of others on Carpenterville Road. In addition, Ron Adams continues to reject the outstretched hands of those with expertise who have agreed to help him with a plan that would truly move forward to address repair and restoration efforts needed at the Pistol River.

To date, the information and plans submitted by the applicant, Ron Adams do not meet the counties requirements to consider granting of a land use permit for gravel extraction and processing on the Pistol River. His initial permit request as well as the recent testimony lacks the scientific data and specificity of operations needed for decision making on this project. In fact, the data presented at the 11/20/19 hearing did not provide data to support his appeal but instead brought forward a whole new plan. This has been a continuing issue throughout the multiple hearings of Ron Adams requests for a permit.

I respectfully request that the Curry County Board of Commissioners support the Curry County Planning Commission's decision to deny the Land Use Permit AD-1907 and move forward with a denial of appeal AD-1901 submitted by Ronald Adams.





Image shows 4 proposed gravel removal sites and location of home at 2

Dear Curry County Board of Commissioners,

The South Coast Watershed Council is a community organization whose mission is to protect and enhance the watersheds within our service area, which includes the Pistol River watershed. A primary objective of the Council is to work collaboratively with communities and landowners to develop and carry out voluntary watershed protection, restoration, enhancement, and community engagement activities. With this objective in mind, the Council would like to express our support for Ron Adams' intent to 'improve the estuary' in the Pistol River watershed and 'help the endangered fish survival'.

As was pointed out in previous comments to the Planning Commission regarding Mr. Adams' proposal for gravel extraction, a restoration-based approach to sediment removal should be approached cautiously, and should consider the habitat types and features that could be restored at this site based on historic and current conditions. Together with the Curry Soil and Water Conservation District and the Lower Rogue Watershed Council (collectively, the Curry Watersheds Partnership), our organizations have the technical expertise and access to historic data sources – e.g., aerial photos, sediment studies – to help us understand habitat features that once existed at the proposed extraction site. We have also recently put in grant proposals to the Oregon Watershed Enhancement Board and the Pacific Marine Estuaries Partnership, to develop a hydraulic model for the Pistol River estuary. This analysis would provide the current conditions of the geomorphology, hydrology, and sediment loads in the estuary, and help us understand the outcomes of different sediment removal scenarios.

The Council is committed to working with Mr. Adams to explore the feasibility of gravel extraction that would lead to meaningful restoration of estuarine habitats in the Pistol River. Mr. Adams has reached out to our organization and has expressed willingness to incorporate these analyses into his plans for gravel extraction. This is not a letter of support for gravel extraction in the Pistol River estuary, nor is it a letter of support for Mr.Adams' current plan for gravel extraction. Rather, this is a letter of our intent to work with Mr. Adams to accomplish a well-planned sediment removal proposal that is driven by restoration, if analyses indicate that that is feasible.
