



Lakes End Drive Airbnb Complaint (9/23/2020)



Sold about 18 months ago. Originally a 2 bedroom/2 bath remodeled to be a 3 bedroom/2 bath with a 1 bedroom/1 bath studio in the garage. All work done with no permits. 2 lawhdry rooms

I brought this to the counties attention in June 2020. It has been allowed to remain open, no penalty for no permits. (How many bedrooms/bathrooms was the septic designed to support?)

Owner lives about 2 blocks away. It has been full all summer. Lots of noise and traffic. Occupants are on vacation so lots of loud parties.

Example: Last weekend there were 3 cars, a motorhome, and 4 vans at the residence. (see photos)

We are being overrun with airbnb's. (see map). This is not the only one on Lakes End Drive.

Why are home owners allowed to have a commercial enterprise (a hotel) in a residential neighborhood?

Is the county going to regulate the airbnb's? Issuing a business license is not enough. Why don't local residents have any say about these commercial enterprises in their neighborhood?

I am asking for two things from the county.

- 1) Close down this illegal Airbnb
- 2) Establish rules and regulations so that local neighborhoods are not overrun with these commercial enterprises and residents have some say in the matter.
