WHEREAS, On May 22, 2023 the Governing Body of the Curry County 4-H and Extension Service District (District) met to hear public comment on the 2023-24 budget for the Curry County 4-H and Extension Service District, as approved by its Budget Committee, which has been published according to law; and,

WHEREAS, that budget requires an ad valorem property tax rate on all property within the district in the amount of \$0.1021 per thousand dollars of assessed value,

BE IT RESOLVED that the Governing Body of the Curry County 4-H and Extension Service District hereby adopts the budget for fiscal year 2023-24 in the sum of \$1,461,557 now on file at the Curry County Extension Service Office; and

BE IT FURTHER RESOLVED that the following appropriations are made for the Curry County 4-H and Extension Service District for the Fiscal Year beginning July 1, 2023, and ending June 30, 2024:
