




## Accreditation

## UNIFORMED PATROL BUREAU

The Uniformed Patrol Bureau is comprised of several units including Patrol, Agricultural Crimes Unit and K-9 Unit. Our Patrol Deputies are responsible for responding to all calls for service, traffic enforcement, conducting initial investigations and effecting arrest. Other units are responsible for investigating Agricultural crimes and our hard-working K-9's provide drug enforcement and tracking abilities.

## DETENTION BUREAU

The Detention Bureau comprises of sworn detention deputies, dually certified deputies and civilian staff, who work in the DeSoto County Jail. The Detention Bureau is primarily responsible for the care, custody and control of detainees. Other responsibilities include the in-processing and out-processing of individuals arrested by DCSO, Florida Highway Patrol, Arcadia Police Department and other Federal/State/Local egencies.

Our School Resource Deputies create and maintain a safe and secure environment for students, teachers, staff and visitors at schools. The SRD program is part of Sheriff Potter's dedication to Community Partnership. Deputies assigned to a school possesses skills to build relationships, solve problems and enforce the law while focusing on the quality of life within the school and the community.



#### **Firearms**

Our Firearms and Weapons Training consists of at least 3 range days, training twice each year. Our law enforcement, detention and SWAT members train with about 40,000 rounds of ammunition each year. DCSO trains using individual movement techniques and group setting environments.

# Crisis Intervention Training

Crisis Intervention Training is required for all staff including law enforcement, detention and civilians. The 40 hour course from FDLE is completed at DeSoto Memorial Hospital, and offered once a quarter.
