- I. <u>Pledge of Allegiance / Call to Order</u>: Commissioner Kingston called the meeting to order at 10:00 a.m. after leading the group in the Pledge of Allegiance and a moment of silence.

- Commissioner Huffman made a motion to approve the Purchase of Service Agreement between Forest County (Children & Youth Services) and Pathways Adolescent Center, 370 N. Seneca Street, Oil City, PA 16301 for the provision of child welfare services effective July 1, 2022 through June 30, 2023. Commissioner Snyder seconded the motion. The motion carried unanimously.
- 2. Commissioner Snyder made a motion to approve the Agreement for Purchase of Services between Forest County and Warren County for the provision of housing and detention services of Forest County inmates at a cost of \$65.00 per day per inmate plus medical costs effective January 1, 2023 through December 31, 2023. Commissioner Huffman seconded the motion. The motion carried unanimously.

- 3. Commissioner Snyder made a motion to approve the Lease Agreement between Forest County and Michael and Susan Geyer, 117 Gilfoyle Road, Marienville, PA 16239 whereby the landlord (Geyers) agree to lease a 15'X15' parcel of land for a 112" pole to be placed as well as a small utility cabinet not to exceed 225 square feet in ground coverage. This pole will be used as part of the Forest County Broadband Initiative. Commissioner Huffman seconded the motion. The motion carried unanimously.

Commissioner Huffman seconded the motion. The motion carried unanimously.

Tax rate for general County purposes: 19.91 mills on each dollar of assessed valuation;

Tax rate for Library purposes: .45 mills on each dollar of assessed valuation:

Per Capita Tax on all persons subject to taxation: \$5.00 for each person

That for the expenses of the County for the fiscal year 2023, tax revenues and other funds available for the fiscal year shall be utilized to support the budget of \$3,278,315.90 for the specific purposes set forth as itemized in the Annual County Budget on file in the office of the County Commissioners. Commissioner Huffman seconded the motion. The motion carried unanimously.

- 14. Commissioner Huffman made a motion for the County Treasurer to transfer \$250,000.00 from the General Fund Money Market Account to the General Fund for operating expenses of the County. Commissioner Snyder seconded the motion. The motion carried unanimously.
- VII. <u>Adjournment:</u> Commissioner Snyder made a motion to adjourn. Commissioner Huffman seconded the motion. The meeting adjourned at 10:10 a.m.
