## RESOLUTION OF APPROVAL COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATION

WHEREAS, Act 179 of 1984 established the Pennsylvania Community Development Block Grant (CDBG) Entitlement Program to financially assist municipalities with a number of community development needs principally benefiting low and moderate income (LMI) persons; and

WHEREAS, Forest County's FFY 2021 CDBG Entitlement is \$211,664 with \$38,099 being earmarked for Program Administration leaving a balance of \$173,565 for a wide range of eligible projects and activities; and


WHEREAS, the projects contained in the CDBG Application address needs identified in the Three-Year Community Development Plan and principally benefit low and moderate-income persons; and
