**RESOLUTION #5 OF 2017
COMPENSATION OF DISTRICT ELECTION OFFICERS**

Resolution to establish rates of compensation and qualifications of all judges, inspectors and clerks of election as set forth in Purdon's Pennsylvania Statutes and Consolidated Statutes, Title 25, Elections and Electoral Districts.

Title 25 P.S. §2682.2

(a) In all counties regardless of class, the compensation of judges of election, inspectors of election and clerks shall be fixed by the county board of elections.

Whereas: The Forest County Board of Elections hereby resolves to establish the following compensation rates for district election officers to become effective January 1, 2018:

Judges of Election	\$140.00
Inspectors of Election	\$140.00
Clerks	\$100.00

Whereas: The Forest County Board of Elections further resolves to establish the following entitlements for district election officers effective January 1, 2018:

Title 25 P.S. §2682.2

(d) For transmitting returns of elections and all materials, all judges of election shall be entitled to receive the sum of \$20.00.

(e) The county board of elections may, in its discretion, require the minority inspector of election to accompany the judge of election in transmitting the returns of elections, in which case the minority inspector of election shall be entitled to receive the additional sum of \$20.00.

(f) The person furnishing transportation to the judge of election and the minority inspector in transmitting the returns and materials shall be entitled to the current state certified mileage rate per circular mile from the polling place to the county courthouse. Only one person shall receive mileage compensation.


(h) Compensation and other payments received by election officials pursuant to this section shall not be deemed income classified and categorized under section 303 of the act of March 4, 1971.

Title 25 P.S. §2684


The county election director shall instruct in the use of the machines, and in their duties in connection therewith, all judges, inspectors of election and clerks who are to serve at the primary or general

election. Each judge, inspector and clerk shall, upon notice, attend such training to receive instruction necessary for the proper conduct of the primary or general election, and as compensation for the time spent receiving such instruction, each judge, inspector and clerk who shall qualify for and serve at such primary or election shall receive the sum of \$20.00 to be paid at the same time and in the same manner as compensation paid for his/her services on election day.


