You are hereby applying for a Short Term Rental permit in accordance with the Zoning Code of the City of Frankenmuth. **New permit requests require a public hearing** before the Planning Commission, while **permit renewals may not require such a hearing**. In addition to the following requirements, all permits are subject to the requirements listed in Section 5.181 of the Zoning Code:

1. Shall not employ anyone who does not reside at the dwelling
2. Shall be operated entirely within the principal dwelling.
3. Shall not use more than twenty five (25) percent of the total square footage of the dwelling and no more than 2 bedrooms. At no time shall the number of guests exceed four lodgers.
4. Shall operate in such a way as that all needed parking is provided on-site and not in the street. If additional on-site parking is needed it should be approved by the zoning administrator and installed and designed in such a way as is common in single family neighborhoods. If outdoor lighting is provided for the parking locations, it must be approved by the zoning administrator. It shall not exceed typical residential installation and be located in such a way as to screen neighboring properties.
5. Shall have a minimum of two exits and meet all the requirements and regulations of the City's Housing Coder per City Code Chapter 61.
6. Each short term rental must maintain a guest register.
7. All licenses shall be issued, transferred, suspended or revoked per City Code Chapter 71.

In applying for this permit, I hereby understand these regulations and will comply with the provisions of this permit, along with all other applicable City Codes. I furthermore attest to be in compliance with said regulations.
