Village of Glencoe At a Glance

About the Village

The Village of Glencoe is a mature community with a population of 8,849, according to the 2020 Census. It is located in the North Shore region of northern Cook County along Lake Michigan, approximately 24 miles north of downtown Chicago. The Village is bounded by the City of Highland Park to the north, the Village of Winnetka to the south, the Cook County Forest Preserve District and Village of Northbrook to the west, and Lake Michigan to the east. The Village is a non-home rule, special charter municipality which operates under the council-manager form of government. The Village is a full-service community, with a consolidated Public Safety Department (police, fire and EMS); Public Works Department that includes all public infrastructure management; Development Services Department that includes building, zoning and planning functions; Golf operations; as well as the department of Administration and Finance Department that includes the Village Manager's Office, clerk function, finance, information technology and human resources.
