Update to Gas-Powered Leaf Blower Restrictions

Effective January 1, 2024, the Village of Glencoe has updated its ordinance to restrict the usage of gas-powered leaf blowers. Gas-powered leaf blowers may only be used during the following times:

- Between April 1 and April 30
- Between October 1 and November 30

Use of gas-powered leaf blowers during all other times of the year is prohibited. This applies to individual property owners, as well as contractors operating within Village limits. Using gas-powered leaf blowers outside of the above dates can result in fines from the Village. Repeated violations can lead to increased fines and revocation of a contractor's landscaper license. There are no restrictions on the use of battery-powered or electric leaf blowers. The Village encourages the use of this type of equipment as an alternative.

Actualización de las restricciones de los sopladores de hojas a gasolina

A partir del 1 de enero de 2024, Village of Glencoe actualizó su ordenanza para restringir el uso de sopladores de hojas que funcionan con gasolina. Los sopladores de hojas a gasolina sólo se podrán utilizar en los siguientes horarios:

- Entre el 1 de abril y el 30 de abril
- Entre el 1 de octubre y el 30 de noviembre

Está prohibido el uso de sopladores de hojas a gasolina durante el resto de épocas del año. Esto se aplica a los propietarios individuales, así como a los contratistas que operan dentro de los límites de la Villa. El uso de sopladores de hojas a gasolina fuera de las fechas anteriores puede resultar en multas por parte del Village. Las infracciones repetidas pueden dar lugar a mayores multas y a la revocación de la licencia de paisajista del contratista.

No existen restricciones sobre el uso de sopladores de hojas eléctricos o de batería. El Village fomenta el uso de este tipo de equipamiento como alternativa.
