## IMPORTANT INFORMATION FOR VILLAGE OF GLENCOE LIQUOR LICENSE APPLICANTS

The Village of Glencoe licenses a certain number of establishments to sell alcohol by the Comprehensive Fee and Fine Schedule in the Village Code. Open licenses are not maintained. The Village's Comprehensive Fee and Fine Schedule is amended to provide for only the number of licenses which have been approved for issuance. The Village President serves as the Liquor Commissioner and reviews a liquor license request upon initial submission of an application, after which the Village Board of Trustees must approve an amendment to the Fee and Fine Schedule regulating the number of licenses issued. The Village Board meets on the third Thursday of each month and materials for the meeting including proposed code amendments are finalized and provided to the Board one week prior to the meeting.

#### **Processing Time**

Please allow **six weeks** for the processing of your liquor license application (new or renewal) in order for background checks to be completed, the Liquor Commissioner to review the application and for the Village Board to have the opportunity to amend the Fee and Fine Schedule regulating the number of licenses issued. The Village will make every effort to process liquor license applications within the six-week period; however, please note that the actual time to process an application may vary. We encourage you to allow as much time as possible to process your application.

### **Background Checks - For NEW and RENEWAL Applicants**

The Village of Glencoe requires that all on-premises officers, agents and managers listed on the Liquor License Application submit for a background investigation at the time of the initial application and then annually as part of the renewal process. "On-premises officers" means that only officers, agents and managers who are on-site at the business. Corporate board members located in different states who are not on-site at a business do not need to be fingerprinted. To complete this process, the applying business must ensure that:

- All on-premises officers, agents and managers complete the Liquor License Application
  Background Investigation Authorization and Release form (page 7) and provide a copy of a
  driver's license or state ID;
- All on-premises officers, agents and managers appear in person at Glencoe Public Safety,
   325 Hazel Avenue, Glencoe IL 60022, with a driver's license or state ID to be fingerprinted and;

• A \$50.00 fee is paid to the Village of Glencoe per the Village's Comprehensive Fee and Fine Schedule for **each person fingerprinted**.

#### **Required Documents - For NEW and RENEWAL Applicants**

The following documents are required to be submitted:

- Completed Village of Glencoe Application for Liquor License (begins on the following page) with any additional pages attached and signed Affidavits (page 6) attached for all on-premises officers, agents and managers;
- Signed Liquor License Application Background Investigation Authorization and Release form (page 7) with a copy of a driver's license or state ID for all on-premises officers, agents and managers listed on the application;
- Copy of State of Illinois Liquor License or Application (once issued the license must be submitted prior to the service of alcoholic beverages and within 30 days of receipt of Village license, failure to do so may result in revocation of a Village Liquor License);
- A certificate of insurance with evidence of liquor liability/dram shop insurance in the amount
  of at least \$1,000,000 per occurrence;
- A current Village of Glencoe Business License (or application in process) for the same address and business name;
- A roster of all officers, agents and employees who sell, serve or prepare alcoholic beverages and evidence of current Beverage Alcohol Sellers and Servers Education and Training (BASSET) certification. For more information visit: www.illinois.gov/ilcc/Education/Pages/BASSET/Home.aspx;
- A business income statement if the classification fee is a lesser amount for alcohol sales of less than 15% of gross sales (or is expected to be for a new business). If a business income statement is marked with the words "Proprietary and Confidential" the Village will take every lawful action to prevent disclosure of it under the Freedom of Information Act (FOIA);
- Payment of all applicable fees including fingerprinting fees and the appropriate liquor license classification fee (an appendix is attached listing the classifications with descriptions and fees, see page 9) and;
- For corporate applicants, the application should include a copy of the State of Illinois
  certificate of incorporation, and, if incorporated in a state other than Illinois, a copy of the
  State of Illinois certificate showing the date that the applicant became qualified under the
  Business Corporation Act of 1983, 805 ILCS 5/1.01 et seq., to do business in Illinois.

- The applicant, and all directors, officers, partners, managers, and shareholders thereof, are not disqualified to receive a local liquor license by reason of any provision of this Chapter, the laws of this State, or the ordinances of the Village;
- The applicant will not violate any of the laws of the State of Illinois, or of the United States, or any ordinance of the Village in the conduct of the applicant's place of business, including, without limitation, the responsible alcohol service training requirements set forth in Section 4-21 of this Chapter;
- The applicant has paid all taxes due and owing to the Village as of the date of the application;
- The applicant may be held liable for any violation of this Chapter by an officer, director, manager, or employee of the applicant, as set forth in Section 4-44 of this Chapter;
- The issuance of a new or renewal local liquor license pursuant to this Chapter will not be deemed as vesting any right to the applicant, or to any partner, officer, director, manager, shareholder, agent, or employee thereof, of an additional local liquor license or to future local liquor licenses; and
- If the applicant is a club, no member, officer, agent, or employee of the applicant is paid or directly or indirectly receives, in the form of salary or other compensation, any profits from the distribution or sale of alcoholic liquor to the club or the members of the club or its guests, beyond the amount of such salary as may be fixed and voted at any annual meeting by the members or by its board of directors or other governing body out of the general revenue of the club

#### **APPENDIX**

### CLASSIFICATION OF LOCAL LIQUOR LICENSES

- (A) Class A: Primary On-Premises Consumption, which shall authorize the retail sale of alcoholic liquor in establishments where on-premises consumption of alcohol is the primary source of revenue for the establishment. The incidental sale or service of food is permitted but not required in Class A licensed establishments. The alcoholic liquor sold may only be consumed on the premises where sold. Patrons entering a Class A licensed establishment must be at least 21 years old or accompanied by a parent or legal guardian. Class A Licenses shall be issued in two subcategories permitting the retail sale of the following types of alcoholic liquor:
  - (1) Class A-1: Beer and wine.
  - (2) Class A-2: Spirits, beer, and wine.
- (B) Class B: Incidental On-Premises Consumption, which shall authorize the retail sale of alcoholic liquor by restaurants, golf clubs, private clubs and other venues where onpremises consumption is permitted. The sale of alcoholic liquor pursuant to a Class B license must be incidental to the sale and service of food, and the alcoholic liquor may only be consumed on the premises where sold. Class B Licenses shall be issued in two subcategories permitting the retail sale of the following types of alcoholic liquor:
  - (1) Class B-1: Beer and wine.
  - (2) Class B-2: Spirits, beer, and wine.
  - (3) Class B-3: Spirits, beer, and wine by a recreational facility owned or operated by a governmental entity.
- (C) Class C: Consumer Retail/Service On-Premises Consumption, which shall authorize the retail sale of alcoholic liquor for on-premises consumption by establishments whose primary business is to offer non-alcohol related consumer goods and services. Examples of such establishments include beauty salons, art galleries, and bookstores. Alcoholic liquor may only be offered for value and may not be offered by a Class C licensee as an inducement to purchase any consumer good or service. The alcoholic liquor may only be consumed on the premises where sold. Class C Licenses shall be issued in two subcategories permitting the retail sale of the following types of alcoholic liquor:
  - (1) Class C-1: Beer and wine.
  - (2) Class C-2: Spirits, beer, and wine.
- (D) *Class D: Off-Premises Consumption*, which shall authorize the retail sale of alcoholic liquor, in the original package, for consumption off the premises where sold only, and not for consumption on the premises where sold. Class D Licenses shall be issued in two subcategories permitting the retail sale of the following types of alcoholic liquor:
  - (1) Class D-1: Beer and wine.
  - (2) Class D-2: Spirits, beer, and wine.
- (C) Class E: Special Events, which shall authorize the retail sale of alcoholic liquor at a

Special Event, which Class E license shall not be valid for a period exceeding eight (8) consecutive hours. Class E licenses may permit the sale of alcoholic liquor either for consumption within the area specifically designated in such license or for consumption off of the premises of the special event, subject to such conditions as the liquor commissioner may impose and record on the license.

- (1) Class E licenses shall be issued in two subcategories depending on the status of the applicant:
- A. Class E-1: For applicants that are registered educational, political, civic, fraternal, religious, or other non-profit organizations.
  - B. Class E-2: For all other applicants seeking a Special Event license.
- (2) A Class E Special Event license will be required for events at which:
- A. Alcoholic liquor is sold or offered for value (including the operation of cash bars, the exchange of purchased drink tickets, or the offering of complimentary drinks with paid admission), regardless of whether the special event is open to the general public or by invitation only; or
  - B. The special event is open to the general public.
- (3) A Class E license will not be required if:
  - A. The special event is by invitation only, not open to the general public; and
  - B. Alcohol is not sold or offered for value at the special event.
- (D) **Class F: Live Performance Theatres**, which shall authorize the retail sale of alcoholic liquor, including beer, wine, and spirits by theatres for consumption on the premises as an incidental and complementary activity to the presentation of live stage performances, provided that:
  - (1) Such sales shall be limited to the period commencing one hour prior to the start of the live stage performance and terminating either (a) one hour after the end of live stage performance or (b) midnight, whichever occurs earlier;
  - (2) Such sales are restricted to the area of the theatre presenting the live stage performance that serves as the lobby; and
  - (3) Alcoholic liquor may only be dispensed by agents or employees of the licensee theatre.
- (E) Class G: Combination On-Premises and Off-Premises Consumption, which shall authorize the retail sale of alcoholic liquor for consumption on-premises and/or off-premises at restaurants or retail establishments. Class G Licenses shall be issued in two subcategories permitting the retail sale of the following types of alcoholic liquor:
  - (1) Class G-1: Beer and wine.
  - (2) Class G-2: Spirits, beer, and wine.
- (F) Class H: Brew Pubs and Craft Breweries, which shall authorize alcohol production facilities including brew pubs and craft breweries to offer alcohol for on- and/or off-premises consumption. Food must be offered for service at all Class H Licensed establishments that permit on-premises consumption.
