Option 1: Submit Comments by E-Mail Prior to Meeting

Public comments received by 4:30 p.m. or one hour before the start of the Golf Advisory Board meeting will be read during the Golf Advisory Board meeting under Public Comment. Any comments received during the meeting may be read at the end of the meeting.

All e-mails received will be acknowledged. Public comment is limited to 400 words or less. E-mailed public comments should contain the following:

- The Subject Line of the e-mail should include the following text: "September 21,2020 Golf Advisory Board Meeting Public Comment"
- Name of person submitting comment (address can be provided, but is not required)
- Organization or agency person is submitting comments on behalf of, if applicable
- Topic or agenda item number of interest or indicate if the public comment is on a matter not listed on the Golf Advisory Board meeting agenda
