#### 1. CALL TO ORDER AND ROLL CALL

Chairperson Gallagher called the meeting to order at 7:05 p.m.

#### 2. CONSIDERATION OF THE JUNE 29, 2021 STF MEETING MINUTES

Upon a motion made by Mr. Healy and seconded by Ms. Brooks, the meeting minutes for July 27, 2021 were approved. Ms. Hostert was also welcomed as a full member by Chairperson Gallagher and was assigned to the Public Awareness and Recycling and Waste Reduction working groups.

## 3. RECAP OF THE GREEN BAY TRAIL DAY

Chairperson Gallagher recapped the Green Bay Trail Day event and asked for the Task Force's feedback on the event. Ms. Latham commented that it was a quiet event but there were some good conversations with the people who did come. The garbage and recycling sorting game was also popular. Another comment was that other stalls gave out freebies to draw people in and that GSTF freebies would be useful for future events. Ms. Hostert suggested having teenagers who are passionate about sustainability, like Ms. Procopi, to draw younger people in. She also stated that the produce bags did not arrive on time, but they can be used for a free giveaway for the next event. Ms. Lin stated that having two people at the event was helpful for fostering conversation. It also helped to have different topics to talk about and that there

were good conversations about leave the leaves, recycling and community solar. Visuals like the big orange bag were helpful for the Simple Recycling textile program. Ms. Tuchman was surprised at how the people who came forward were very engaged, and overall, found taht the recycling element was very educational. Ms. Hostert said that people always have questions about recycling because there is so much involved with it.

Chairperson Gallagher also reminded Mr. Healy about preparations for the bird mascot costume.

# 4. WINTER LIBRARY WEBINAR PROGRAM PLANNING

The Task Force continued planning for the fall Library webinar programs and reviewed the plans that are currently in place. The Leave the Leaves program will take place in early October and a postcard will go out to all residents about the event. Additionally, the solar panels and electric vehicles program will have to take place during the winter programs.

The group turned to winter programing. Chairperson Gallagher stated that the considering the results of the report U.N. climate report, the group should find someone who worked on the report to speak about what is happening at a global level and bring it down to a local level. Mr. Mulvaney had a contact and Mr. Healy also suggested bringing someone he knew from the United Nations to speak as well. Chairperson Gallagher suggested that the group could find high caliber speakers, they should work with the local Go Green groups to promote the event and maybe share the speaker costs, which may be higher.

Plans for a March webinar were discussed as well. Ms. Lin suggested having a program about green lawns, green landscapes or what to plant in the spring (native plants, plants that do not require fertilizer, plants that attract bees or other pollinators). Ms. Tuchman suggested tapping a landscape architect in the area as a speaker for the program. Vice Chair Mulvaney suggested reaching out to the Golf Course for someone and connecting back to the Glencoe mascot or hummingbirds in general.

Ms. Lin also stated that the group should coordinate with Friends of the Green Bay Trail for March or April programming to avoid overlap.

# 5. MEMBERSHIP DISCUSSION

Chairperson Gallagher led a discussion about the merits of adding community group liaisons verses residents with a passion for sustainability to share the workload, after last month's discussion about adding a liaison to the Task Force to represent the Friends of the Green Bay Trail.

The Task Force also discussed a rebranding campaign to help introduce new members and volunteers into the group. Several members shared their experiences with the Task Force. Ms. Hostert stated that the GSTF felt exclusive as an outsider and had suggestions on how to make the group feel more open to new volunteers and members. Several other members agreed.

The methods of introducing new people to the GSTF was discussed. Ms. Procopi stated that she was required to go to a meeting first before being on the Task Force and suggested having new people do that prior to being nominated, an idea that was accepted by Chairperson Gallagher. Ms. Lin suggested having new people start on subgroups rather than the official group. Ms. Hostert suggested advertising subcommittee meetings through NextDoor, the Village website and the Village e-newsletters, although Ms. Lin stated that some groups communicate via email rather than meetings and Ms. Culver stated that it might be difficult to come up with more concrete meeting times due to scheduling conflicts.

# 6. LEAVE THE LEAVES CAMPAIGN

The Task Force discussed current progress on the Leave the Leaves Campaign. The working group managed to secure a Library webinar on the topic on Monday, October 4 at 7 p.m. with a horticulturist. The group is also working on a mailer, promoting the importance of leaving the leaves and the upcoming webinar.

The leaf blower ban was also discussed. Ms. Culver reminded the group that a large part the effort is working toward the goal of converting all gas-powered leaf blower to electric with education and adopting amendments to the gas-powered leaf blower ordinance. The Task Force will continue to discuss. Mr. Mau stated that there was also progress with major landscapers in the Glencoe area and with the Village's own Public Works Department regarding following the gas-powered leaf blower ordinance.

Chairperson Gallagher discussed the Farmer's Market on September 9<sup>th</sup> and September 23<sup>rd</sup>, which the Task Force will staff and promote the Leave the Leaves campaign, among other topics. He stated that volunteers will be coordinated offline. Ms. Culver agreed that there needs to be a catchier attraction to the table. Ms. Hostert stated that there should be multiple topics because more people should be attracted to the table.

## 7. SUBCOMMITTEE UPDATES (AS NEEDED)

*B. Green Lawns:* The working group has submitted a plan. Mr. Healy stated that the working group wants to do more with the official bird mascot, such as creating a mannequin or a physical mascot costume. The group also wants to include the symbol in various communications (such as between the Village and the School District, the Library, and the Park District) and to do a 'Dear Ruby' section for asking or answering questions on the website as an equivalent to Wilmette's Dear Ruby. Ms. Culver suggested adding it *to Inside Glencoe* and using Dear Ruby to explain why it is good to walk or bike to school and maybe putting it on a vehicle sticker.

C. *Public Awareness:* This group discussed how events like the Park District's Summer's Last Blast event on September 3<sup>rd</sup> could be more sustainable or how the Task Force could potentially get involved with the event. It was generally agreed among the Task Force members that it was late to get involved in the event, but that the Task Force would like to

see entities create events that are more sustainable and would like to see more resources being put towards that effort. There was a suggestion to involve a company like Collective Resources to pick up all the compost and have 100% compostable materials. The Task Force members generally agreed that there is a need to recognize the waste that events create and to understand the costs involved in making events more sustainable.

# 8. GLENCOE COMMUNITY BOARD AND COMMITTEE UPDATES

*A. Village:* Mr. Mau said that there is a conditional offer extended to an individual for the position of Public Works Management Analyst, who would serve as the new Sustainability Task Force Village staff liaison. The new analyst is expected to start by September 13. Ms. Rachel Overby, the sustainability intern, was also recognized on at her last GSTF meeting.

# 9. OTHER BUSINESS

No other business was brought before the Task Force at this time.

## **10. PUBLIC COMMENT TIME**

No public comments were received.

## 11. CLOSING FAREWELL AND ADJOURN

Then there being no further business to come before the GSTF, a motion to close the meeting was made by Vice Chairperson Mulvaney and seconded by Ms. Culver. The meeting was adjourned at 8:54 p.m.

# Glencoe Village Board Leaf Blower Strategy Proposal Glencoe Sustainability Task Force

#### Introduction

Gas-powered leaf blowers are a well-known source of significant noise pollution, but less well-known is the fact that they also cause quantifiable air pollution hazardous to the health of residents, Village employees and landscape workers. The emissions of 2- and 4-stroke gas leaf blower and mower equipment have been well documented by the US EPA and include such toxic and carcinogenic chemicals as volatile organic compounds (VOCs), benzene, nitrogen compounds (NOx), butadiene and formaldehyde. These substances have been linked to cancer, heart disease and other illnesses, with increasing evidence of health risks for children, seniors and those with compromised immune systems, even from short term exposure.<sup>i</sup> Unlike car engines, leaf blowers to not have emissions controls. There is also the very real threat of climate change caused by the kind of greenhouse gas emissions originating from gas-powered equipment.

Because of these factors, the Glencoe Sustainability Task Force proposes a plan for shifting the use of gas-powered blowers to electric alternatives in Glencoe, with the possibility of combining our efforts with those of Highland Park, Wilmette, Winnetka and Kenilworth. This idea is not reinventing the wheel. There are numerous communities around the country that already have made a similar conversion. More than 100 cities in the U.S., including Washington, D.C., have banned gas-powered lawn care equipment, and many others, including Glencoe, have restricted times during the day and seasons/months when they can be used. In our region, Arlington Heights, Lincolnwood, Winnetka, Wilmette and Highland Park all have imposed similar restrictions, with Highland Park expanding theirs in 1999. Illinois Senator Laura Fine introduced Senate Bill 3313 in 2020 to outlaw the sale of gas-powered leaf blowers statewide, but the bill failed in committee in 2021. Our proposed plan below is meant as a local solution to keep these toxic emissions out of our air. The Glencoe Sustainability Task Force is currently conducting research with Highland Park, Wilmette, Winnetka and Kenilworth to share lessons learned, elevate common understanding and acknowledge an intent to collaborate.

#### **Proposed Approach**

- 1. Glencoe has limited restrictions on the use of gas-powered blowers including:
  - a. Seasonality
  - b. Hours
- 2. The Task Force proposes an extension of those initial requirements, the ultimate aim of which is to ban the use of the gas-powered lawn equipment. We could begin with an outright ban, as the State attempted to do. However, due to the cost of new electric blower equipment, financial ability of contractors and other factors, that may not be as practical an approach as some might wish. (I DISAGREE..I THINK A POLICY THAT SAYS:AS OF 2025, GAS POWERED LEAF BLOWERS WILL BE BANNED, CAN BE PASSED NOW..JUST PUT A LATE START DATE..AND COUPLE THAT END GOAL WITH SOME OF THESE BABY STEPS)
- 3. But, due to documented health concerns and the existing threat of climate change, there is an urgency to the situation. The following table provides the elements of our proposed strategy and a step-by-step process for achieving a switch to electric-powered equipment. Our short-term activity

will be to research these components in other communities and to verify their application and appropriateness for Glencoe.

# Goal:

Water Conservation

# **Objective:**

Use and Distribute Potable Water Efficiently to reduce Glencoe's per capital water consumption

# Strategy:

Create a comprehensive and actionable list of activities for all Glencoe stakeholders

# Actions

# Near term (1 year)

- Designate a Village staff member to serve as the Water Conservation Coordinator to serve as an in-house advocate, data collector and resource for water conservation.
- Establish a multi-media water education program for residents, institutions & businesses. Use educational resources developed by trusted sources such as the Sierra Club, NRDC, UL Labs, CMAP, LWV, Consumer Reports, APWA, MWRD, USGBC, ICC and USEPA. Continue to work with Library to develop resource materials and co-sponsor events, speakers and films. Continue sustainability blog Manager's weekly report and column in Village Newsletter for ongoing education.
- Leverage and share AMI water meter data to encourage residents and businesses to identify and mitigate water loss. Print information on water bills
- Enforce the current irrigation rules and adjust irrigation habits to only water plants when & where needed. Coordinate with education efforts at the Chicago Botanic Garden.
- Adjust current water rates to promote conservation with price signals. Prepare residents for future increases.
- Challenge the Village Government and allied institutions to reduce water consumption and report results.
- Conduct a staff\_survey of water efficiency measures in all municipal facilities
- Revise tree planting & protection requirements to reflect best practices. Continue participation in "Tree City" program
- Work to reduce peak water use for landscaping during the summer through rain water management including proper irrigation, rain barrels, buried downspouts, soil sensors, rain gardens, plant selection and permeable surfaces.

# Net Positive Water Use

# Mid term (1-3 years)

- Provide water use audits, neighbor comparisons & benchmarks with data from the new meters (<u>similar to Comed energy use reporting program</u>)
- Encourage residents to replace old water fixtures, toilets, dishwashers and clothes washers with efficient EPA approved models ( these actions have the most impact on indoor water use)
- If legal, adopt advanced "Water Sense" conservation fixtures as part of the plumbing code (This may require "Home Rule.")
- Continue education & regional water conservation programs

# Long term (3+ years)

- Participate with IDNR, MWRD and CMAP in regional efforts to conserve water
- Revise stormwater management & erosion control construction codes using the ICC Green Code as a guide
- Investigate providing financial incentives to residents for water conservation rebates or inspection fee waivers for fixture and toilet replacement.
- Explore required residential water retrofits upon resale, purchase or reconnection (as recommended by CMAP)
- Participate with MWRD & LCSWMA on stormwater management & water quality issues
- Explore consideration of a stormwater management utility fee such as used in Winnetka
- Continue education & regional water conservation programs

# Village of Glencoe Sustainability Task Force Ravines and Tree Canopy Priority

**Planning Document for 2021** 



## <u>The Issue</u>

The ravines and tree canopy represent critical natural resources to Glencoe. Both are resources which are largely privately held creating a set of unique management issues given their importance to the Village as a whole. The ravines are under increasing erosion pressure as we experience more frequent and heavier rain events resulting in excessive stormwater run-off.

The Vision

The Objectives

<u>Strategies</u> Create a comprehensive plan for securing the ravines addressing the issue of reducing the volume of wastewater run-off into the ravines and including the development of a private-public collaborative effort to restore and maintain the ravine system.

Collaborate with the Lake County Storm Water Management Commission (LCSWMC) and Highland Park in ravine system management planning. Determine what are best ecosensitive practices to control storm water run-off into the ravines and incorporate them into all relevant Village ordinances.

Work with staff to incorporate best practices in all Village new construction, sub-division development and tree removal ordinances around preservation of heritage trees.
