What it means

To reduce demand on natural water resources, reduce burdens on the village water supply and wastewater systems. Positive use also reduces energy use, water treatment chemicals, infrastructure cost and maintenance while promoting public health and preservation of the natural environment.

Past Village Efforts

The Village of Glencoe has taken several measures to reduce the consumption of both potable and nonpotable water in its water system. The Village has aggressively pursued stopping water leakage from the distribution system. It has increased the consumer cost of water to reduce demand and encourage conservation. The Village adopted the MWRD water management code for reducing outdoor landscape water use through time & day based watering requirements as well as the EPA/MWRD stormwater management requirements to manage and reduce stormwater runoff. The street sweeping program was expanded to reduce stormwater pollution from roadways and parking lots. The Glencoe Golf Course has converted its irrigation system to a system that uses untreated lake water in place of potable water. In addition, the Glencoe Golf Course expanded it the amount of natural open space on the course which does not require watering.

Possible New or expanded Programs

Improve construction related stormwater management through erosion and sedimentation control, minimizing site disturbance and retaining stormwater on site (Model codes are available)

Adopt new controls over landscape irrigation such as rain & soil sensor controllers

Participate in regional watershed management plans for Lake Michigan and Skokie River

Adopt state-of-the-art plumbing fixture codes as recommended by the USEPA (Water Sense)

Expand public education programs to increase awareness and conserve water resources

Establish stormwater bioswales in public R-O-Y as used in Milwaukee and Kenilworth.

Reduce the use of salt on streets / use substitutes when necessary

Inspect & upgrade water infrastructure including treatment, distribution and monitoring

OBJECTIVES: Strong civic engagement, preservation and celebration of culture and history, diverse and affordable housing, and accessible public spaces and services for daily needs.

Improvements to strengthen civic engagement:

- **Cycling:** can be for all ages, and for all seasons. The need to promote the use of bikes, that bike riding can be a way of life rather than just a way getting fit.
 - Have painted marked cycle paths on all main routes around Glencoe, and to coincide with the safe routes to school map
 - More signage informing motorists of cyclist.
 - More bike racks around town
 - Just before the start of the new school year banners are hung around town reminding the community that more children will walking and biking to school.
 - Hold regular walk/bike to school and work events through out the year.
 - Launch this push with a biking event. Once a year Chicago hosts the event 'Bike the Drive'. Lake shore Drive is closed to cars on one summertime Sunday, turning this fantastic expressways into bike friendly experience. We could do something similar, perhaps closing Green Bay Road from Hubbard Woods up to the Taffik center and then into town on Vernon. A large convey of cyclists riding for fun, it could be an annual event!

OBJECTIVES: Strong civic engagement, preservation and celebration of culture and history, diverse and affordable housing, and accessible public spaces and services for daily needs.

- Something to encourage multi-generational socialising.
 - Somewhere that hosts live music, cinema (cultural films, the classics, subtitled foreign films), open mike nights, etc. That are inclusive to teens/young adults.

Hometown, is a good example of somewhere with a good atmosphere that is busy and has a great generational mix of people, Glencoe needs more places that encourage an generational mix.

- Glencoe has may parks that are fantastic, but are mostly playgrounds geared to young children. Perhaps in these parks the introduction of other actives eg. permanent table tennis tables, a boules lane, seating that encourages gathering, chatting, relaxation, rather that just a couple of benches in a row could encourage a stronger civic engagement.
- The green spaces around the Glencoe's town centre and on the green bay trial could also include interesting seating areas to encourage people to eat there lunch outside, and socialise during lunch hours and free time.
- Encourage and attract small retailers/businesses that are focused on sustainable business practice in to Glencoe.
