- Topic or agenda item number of interest, or indicate if the public comment is on a matter not listed on the Commission meeting agenda

The regular meeting of the Glencoe Council for Inclusion and Community of the Village of Glencoe conducted virtually in accordance with Governor Pritzker’s Executive Order was called to order by Co-Chair Hilary Scott at 5:33 p.m. on the 1st day of June, 2022.

Prior to roll call, Co-Chair Scott stated that pursuant to recently adopted amendments to the Illinois Open Meetings Act (OMA) included in Public Act 101-0640, the Council for Inclusion and Community was being conducted as a virtual meeting via Zoom video conferencing software. She also stated that a quorum of members of the Council were present via remote access and that Assistant Village Manager Sharon Tanner was physically present at Village Hall as required by the OMA.

Logo Design

Co-Chair Scott began the discussion by asking Member Mali and Member Mysel to share background about development of the logo prior to requesting feedback. Member Mali and Member Mysel shared that the initial discussion. Member Ruben shared a preference for the logo with three silhouettes. Member Kirk McKenzie agreed that the three silhouette logo was preferred and suggested that different silhouette could show more diversity and could be modified based on an initiative or activity of the Council. Member Moses suggested that the silhouettes could be turned in a conversational style.

The Council members discussed an idea to have a logo design contest or share multiple logo options with the community and ask the community to vote. The Council expressed consensus to continue working with the draft logo and develop modifications.

Farmer’s Market – June 2

Co-Chair Guzman noted that Council members signed up to work at the Village’s table at the June 2 Farmer’s Market. He asked the Council for feedback about how frequently the Council would like to participate in the Farmer’s Market. Co-Chair Guzman suggested that the Council participate in Farmer’s Market events the week before a scheduled Council meeting or event.
