She said that the Village has used the same methods of advertising, and recommended that the Commission consider a motion to extend the application deadline to 5 p.m. on February 16, 2017. She said that staff is planning to evaluate factors that may potentially limit the Village's applicant pool and whether there are any aspects of the eligibility rules that the Commission may want to consider amending in the future.
