(the “Alley”).

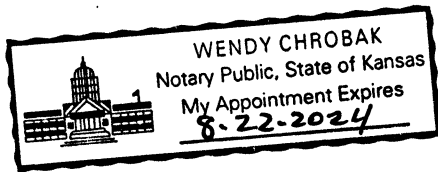
