**ORDINANCE NO. 020-2022-182**

AN ORDINANCE AMENDING SECTION 14-101 OF CHAPTER XIV, ARTICLE I OF THE CODE OF THE CITY OF HESSTON, KANSAS TO INCORPORATE BY REFERENCE THE STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES (49<sup>TH</sup> EDITION), AS PUBLISHED BY THE LEAGUE OF KANSAS MUNICIPALITIES IN 2022.

WHEREAS, pursuant to K.S.A. 12-3009 *et seq.*, and K.S.A. 12-3301 *et seq.*, all as amended, the City of Hesston, Kansas (the “City”) desires to incorporate by reference the Standard Traffic Ordinance for Kansas Cities (49<sup>th</sup> Edition), as published by the League of Kansas Municipalities in 2022 (the “STO”), all as set forth in the Code of the City of Hesston, Kansas (the “Code”); and

WHEREAS, the governing body of the City finds it advisable to incorporate the STO by reference and to amend the Code to reflect its incorporation.

NOW, THEREFORE, BE IT ORDAINED, BY THE GOVERNING BODY OF THE CITY OF HESSTON, HARVEY COUNTY, KANSAS:

SECTION 1. The City hereby incorporates by reference the Standard Traffic Ordinance for Kansas Cities (49<sup>th</sup> Edition), as published by the league of Kansas Municipalities in 2022, with certain deletions and modifications set forth in the Code. Accordingly, Section 14-101 of the Code is hereby deleted and amended to read as follows:

14-101. INCORPORATING STANDARD TRAFFIC ORDINANCE. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Hesston, Kansas, that certain standard traffic ordinance known as the Standard Traffic Ordinance for Kansas Cities (49<sup>th</sup> Edition) prepared and published in book form by the League of Kansas Municipalities in 2022, save and except such article, sections, parts or portions as are hereafter omitted, deleted, modified or changed, such incorporation being authorized by K.S.A. 12-3009 through 12-3012, inclusive, as amended. No fewer than three (3) copies of the STO shall be marked or stamped “Official Copy as adopted by Ordinance No. 020-2022-182” with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this section and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours.

SECTION 2. Except as expressly amended or supplemented with the additional provisions outlined in the Code, including, but not limited to, Sections 14-102 through 14-104

(regarding Traffic Infractions and Traffic Offenses; Penalty for Scheduled Fines; and Amendment to STO Section 51), other ordinances or portions thereof in conflict with this Ordinance are hereby repealed.

SECTION 3. This Ordinance shall take effect and be in full force from and after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary hereof certified as legally accurate and sufficient by the City Attorney.
