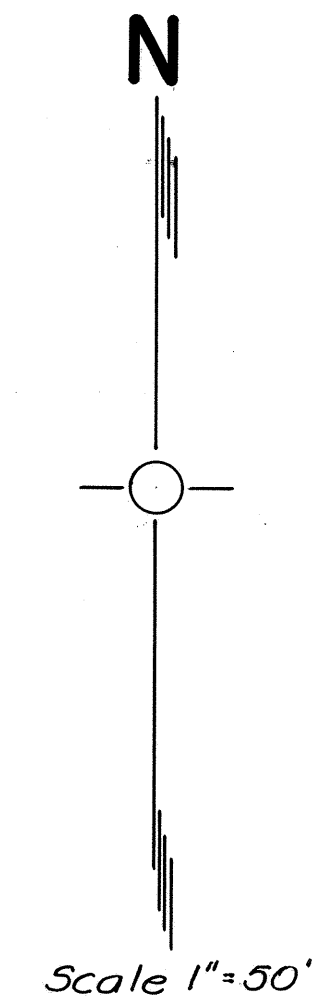
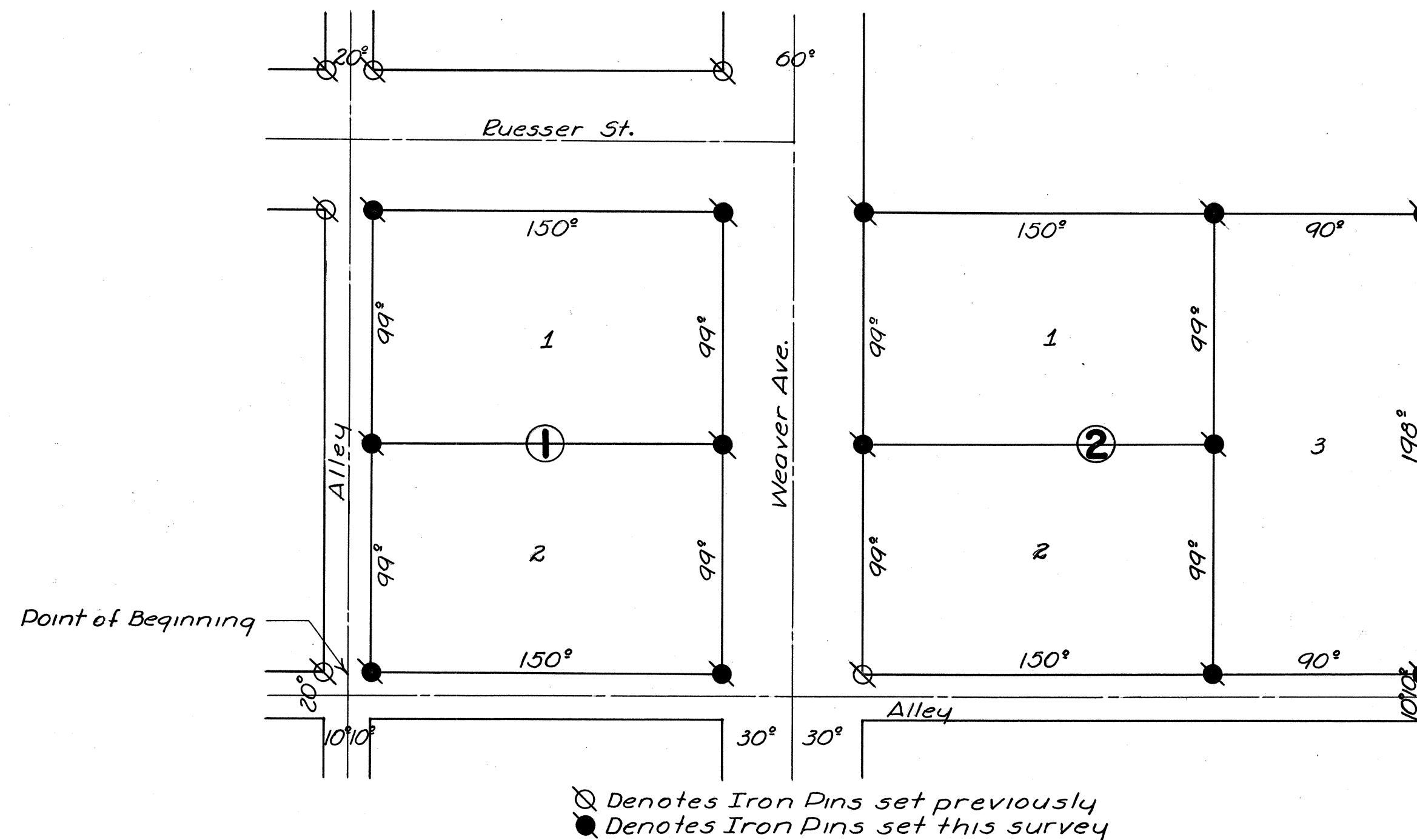


**CORRECTED PLAT

SMITH, its Director, Clerk, and Treasurer respectively, are owners of the following described property: Beginning at a point 200 feet East of the Southwest corner of the West One-Half of the Northeast Quarter of the Northeast Quarter of Section 16 Township 22 South Range 1 West; thence North 198 feet; thence East 460 feet; thence South 198 feet; thence West 460 feet to the place of beginning; and that we have caused the aforesaid tract to be surveyed and sub-divided into blocks and lots and streets and alleys, of location and dimension as shown by the accompanying plat, for the purpose of recording and conveying same by numbers of lots and blocks as shown by the aforesaid plat, to be known as the Corrected Plat of Blocks 1 and 2 Bachmans Addition to the City of Hesston, Harvey County, Kansas.

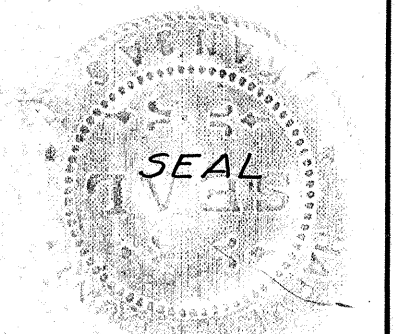
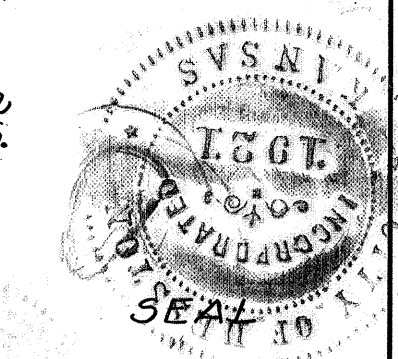
