

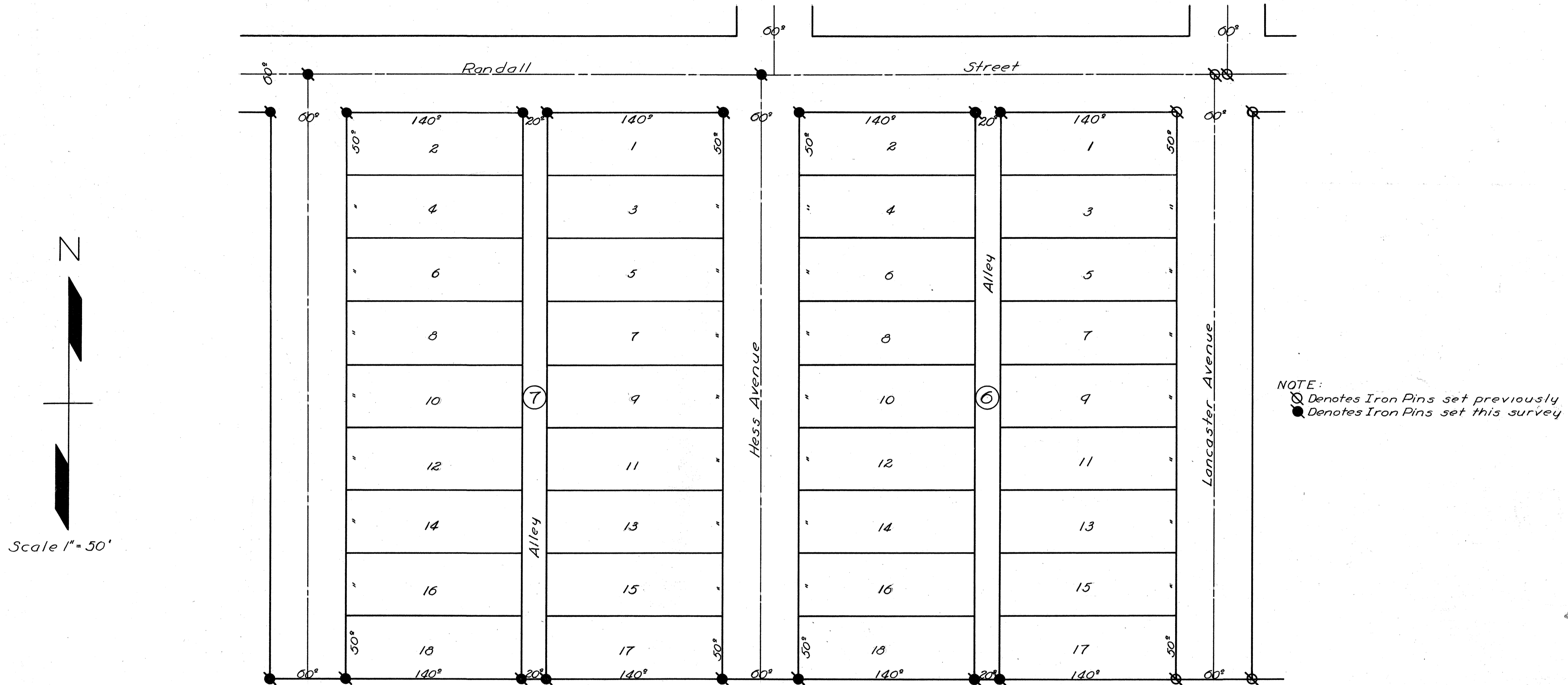

We Nelson Kaufman, Melvin Louver, Forrest Kenagy, Harry Diener, & Howard Zehr, Trustees of the Hesston Academy and Bible School do hereby certify that we hold in trust for the Mennonite Board of Education, a corporation, with power to plat and convey the following described real estate lying and situated in the County of Harvey and State of Kansas to wit; Beginning at a point 430 feet West and 30 feet South of the intersection of Shaver Avenue and Randall Street in the City of Hesston; thence South 450 feet along the West boundary of Lancaster Avenue which is also parallel to Shaver Avenue; thence West 720 feet parallel to Randall Street which center line is also the dividing line of Section 16, Township 22 South Range 1 West; thence North 450 feet; thence East 720 feet to the place of beginning; that we have platted said tract by dividing same into Blocks and have subdivided said Blocks into Lots and numbered said Blocks and Lots for the purpose of disposing of the same by numbers, that we have laid out Streets and Alleys, that size of said Blocks and Lots and Streets and Alleys are as indicated and shown on said plat. That we hereby dedicate to the public for public use the Streets and Alleys shown on said plat hereto and made a part hereof.

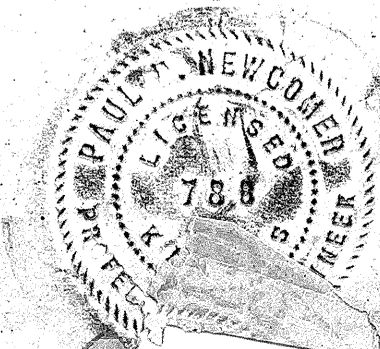

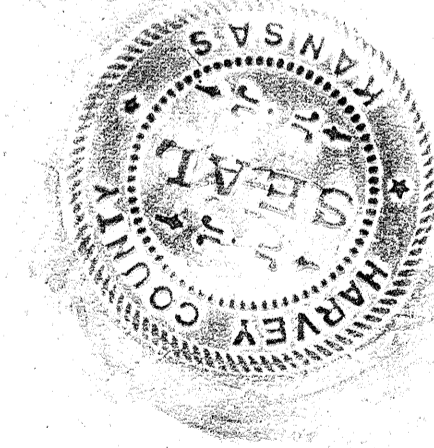

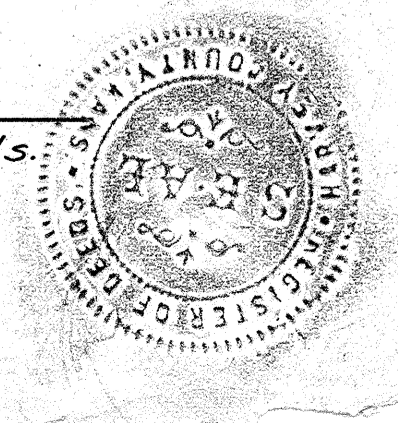
