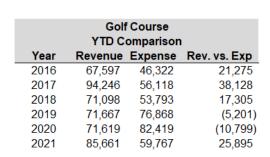
EXECUTIVE SUMMARY

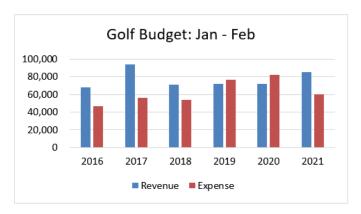
Pooled Cash and Debt (Exhibit I) – The City's total pooled cash position is approximately \$10.7 million. The City's debt of \$12.0 million is made up of four G.O. Bonds that are paid primarily through special assessments, two PBC Bonds for the library building and the recreation project, the golf cart lease-purchase, two golf cart grounds equipment lease-purchases and a revolving loan for the wastewater treatment plant upgrades. The final lease payment for the golf carts was made in February.

<u>Operating Expenses to Budget (Exhibit I)</u> – All funds are withing budget for the year with the exception of the Utility Fund. Unexpected expenses for natural gas purchases in the month of February are pushing this fund out of budget.

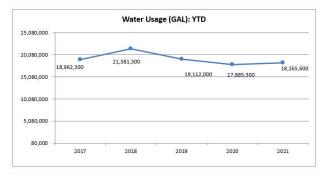
<u>The General Fund (Exhibit II)</u> – The General Fund, as with all tax supported funds, received the largest distribution of property taxes for the year. Expenses are typical for this time of year.

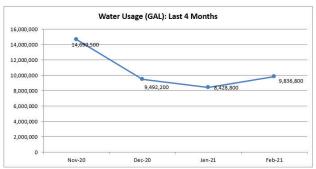

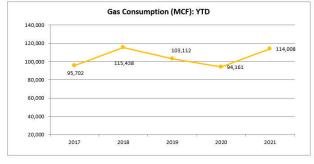


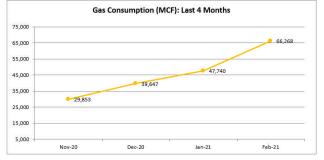

PBC, Land Bank, Business Utility Grants (Exhibit XII) – The Business Utility Grant Fund was added to this section of the financial statements. In April the \$5K City portion of the grant was added to the fund as revenue. In May the \$5K Community Foundation grant was received. Business Utility Grant Assistance was provided in the amount of \$8,370 that went to 10 Hesston businesses.

CVB Grants Awarded Year to Date:

Due to COVID-19, we did not receive any grant requests for the 2020 calendar year. All events and activities that would have qualified for CVB funding were cancelled, postponed or significantly modified due to the pandemic. Our grant activity for 2021 will be dependent on organizations' abilities to move forward with activities and the balance of our funding as it has been significantly impacted by the decrease in overnight stays.

Additional CVB Financial Activity:

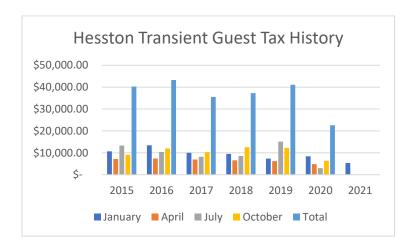
Funding 50% of the Chamber's Executive Director's salary. As a result of this financial allocation, CVB dollars have supported the following work:

- Updated Community Visitors Guide:
 - New for 2020 was a partnership between the Hesston Chamber and the Hesston Record in putting these together.
 - They went out to all households in one mailing of the paper.
 - o We've distributed around town to community partners.
 - o A copy is included in the new resident welcome bags.
 - We mailed boxes of the guides to 12 different travel information centers across the state of Kansas (this is a shift from what has been done in the past and offered significant cost savings).
- The Executive Director continues to partner with local organizations and events already established to encourage visitors to Hesston to stay overnight and dine locally when visiting the community. Anticipated partnerships for 2021 include:
 - State Golf tournaments: We continue to partner with Grady Pauls in contacting each qualifying team and inviting them to stay overnight in Hesston.
 - Home Sweet Hesston: Expanded event and partnerships with the Chamber/CVB remains the lead coordinator for this event.
 - Holly Jolly Hesston/Dyck Arboretum Luminary Walk: includes the downtown tree lighting; continued opportunity to grow and expand this event, especially with the Santa sleigh.
- Attendance at the 2021 MAKO Conference in Branson in May:
 - While a Chamber of Commerce conference, we believe there will be resources and contacts made that will also assist from a CVB standpoint.
- Continued leadership and work with the Grocery Store Task Force which impacts not only community members, but visitors to Hesston as well.
- Welcome Bags:
 - o Relaunched from what has been done in the past.
 - These are distributed to new residents via local realtors, apartment complexes, school district, Hesston College and by request.
 - o Include visitor and business resources

- South Central Kansas Tourism Region Committee
 - o Remain an active member of this organization
 - Have also been appointed as an at-large board member of the committee for the 2021 calendar year
- Updated listings on the TravelKS.com website to ensure our restaurants, lodging and retail partners all have current/updated information represented
