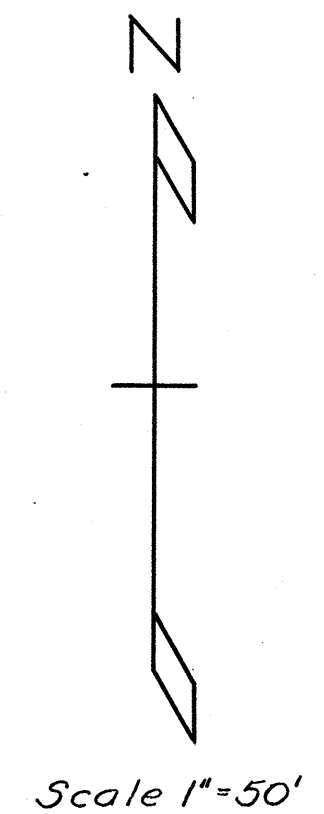
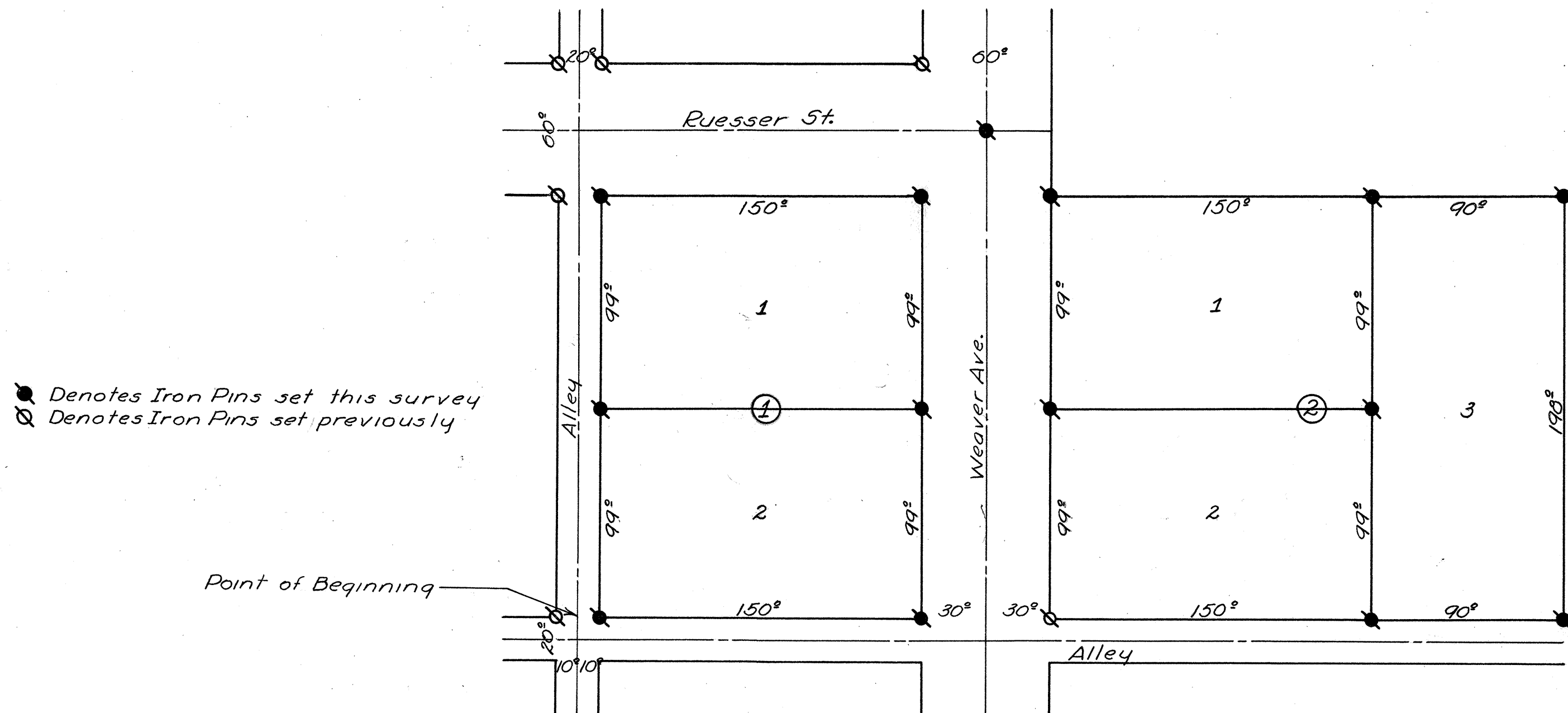


PLAT OF SURVEY

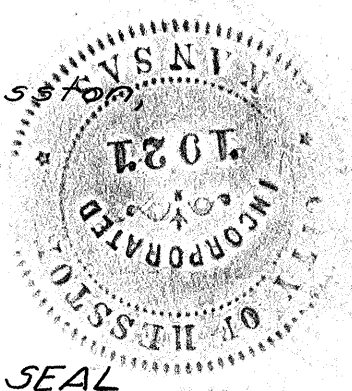

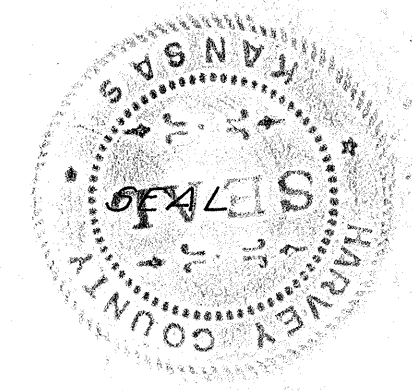

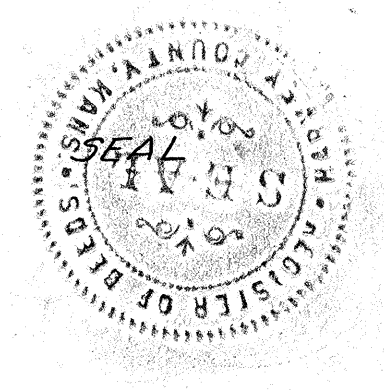
