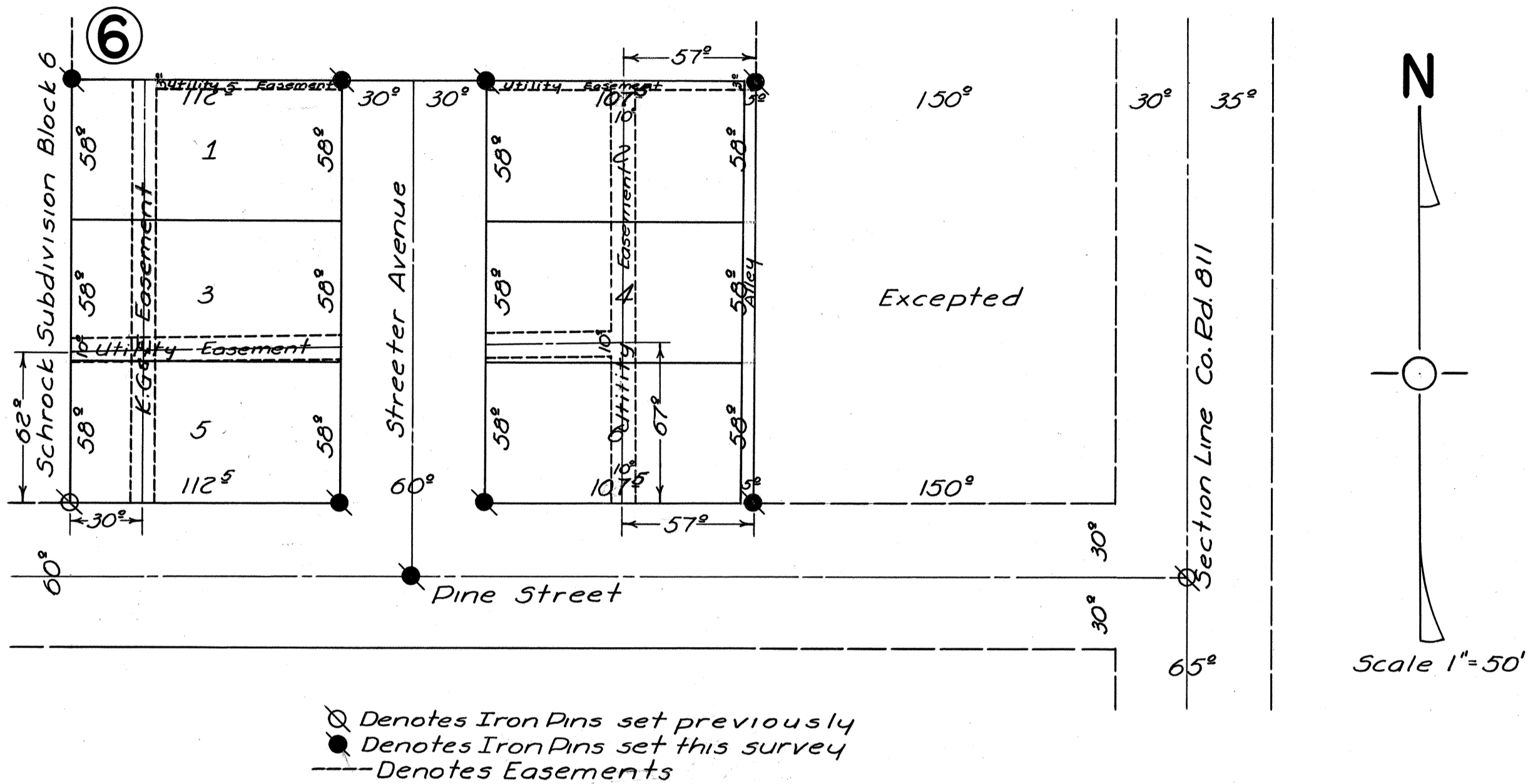


**DYCKS SUB-DIVISION

Know all men by these presents that we Jacob H. Dyck and Fannie E. Dyck his wife, and the City of Hesston by and through its Mayor and Clerk, are the owners of a part of Block 6 Home Addition to the City of Hesston, Harvey County Kansas described as follows: Beginning at a point 150 feet West of the Southeast corner of said Block 6; thence West 285 feet along the South line of said Block 6; thence North 234 feet; thence East 285 feet more or less parallel to the South line of said Block 6 to a point 150 feet West of the East line of said Block 6; thence South 234 feet to the place of beginning. That we have caused said tract to be surveyed and sub-divided into lots for the purpose of conveying the same by the numbers as shown by the accompanying plat.

The streets, <sup>alley</sup> and easements as shown are hereby dedicated to the public use and benefit, except the easement to the Kansas, Gas & Electric Co., which was conveyed by prior owners for the use of said company, and is so recorded.
