 County, Kansas.

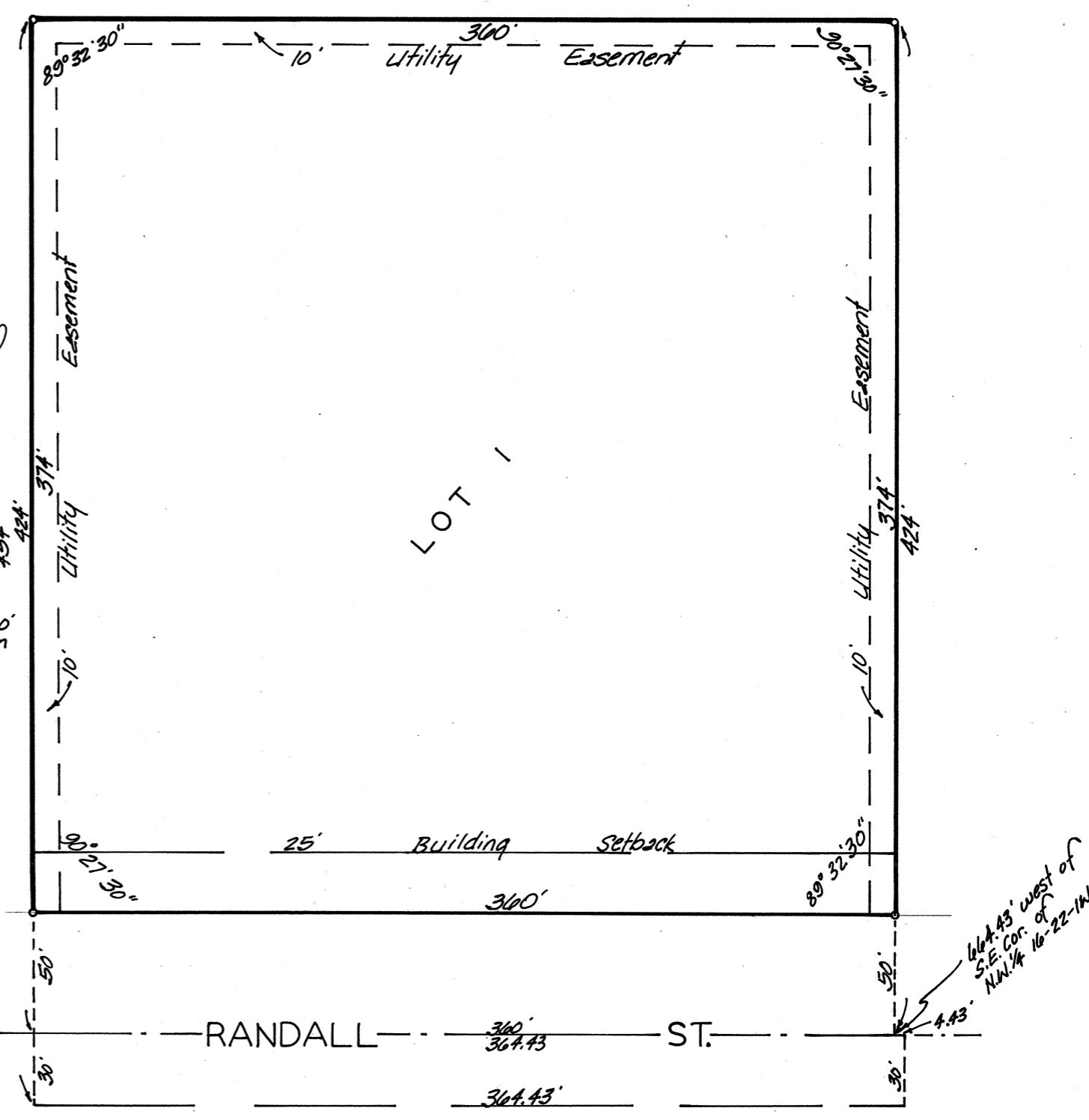
