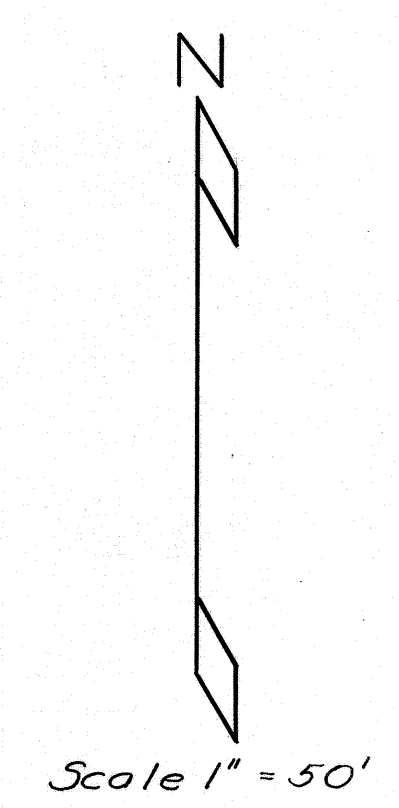
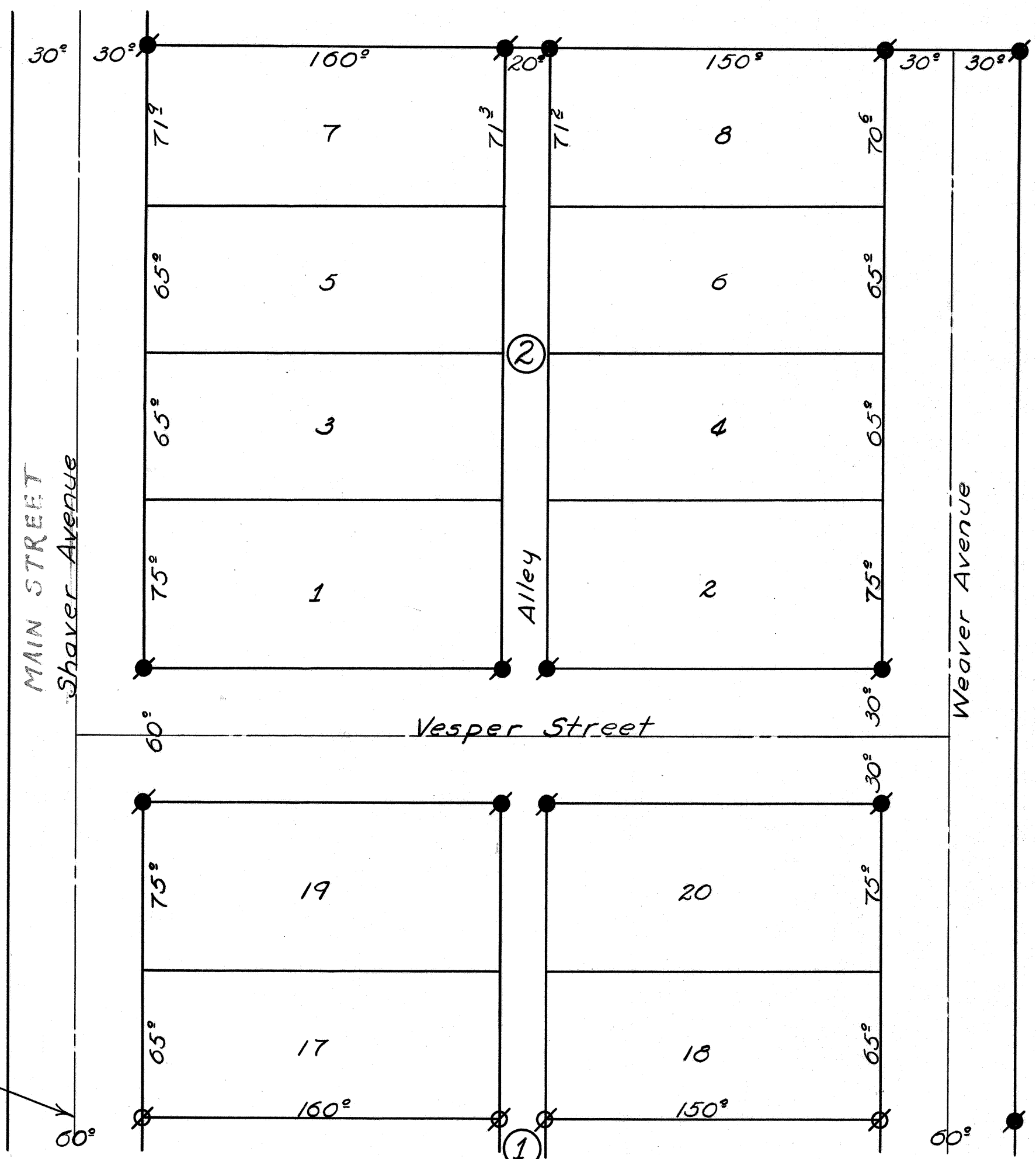


PLAT OF SURVEY

CITY OF HESSTON, HARVEY COUNTY KANSAS



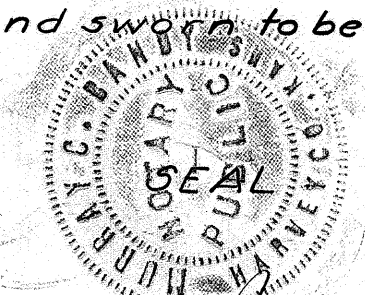
