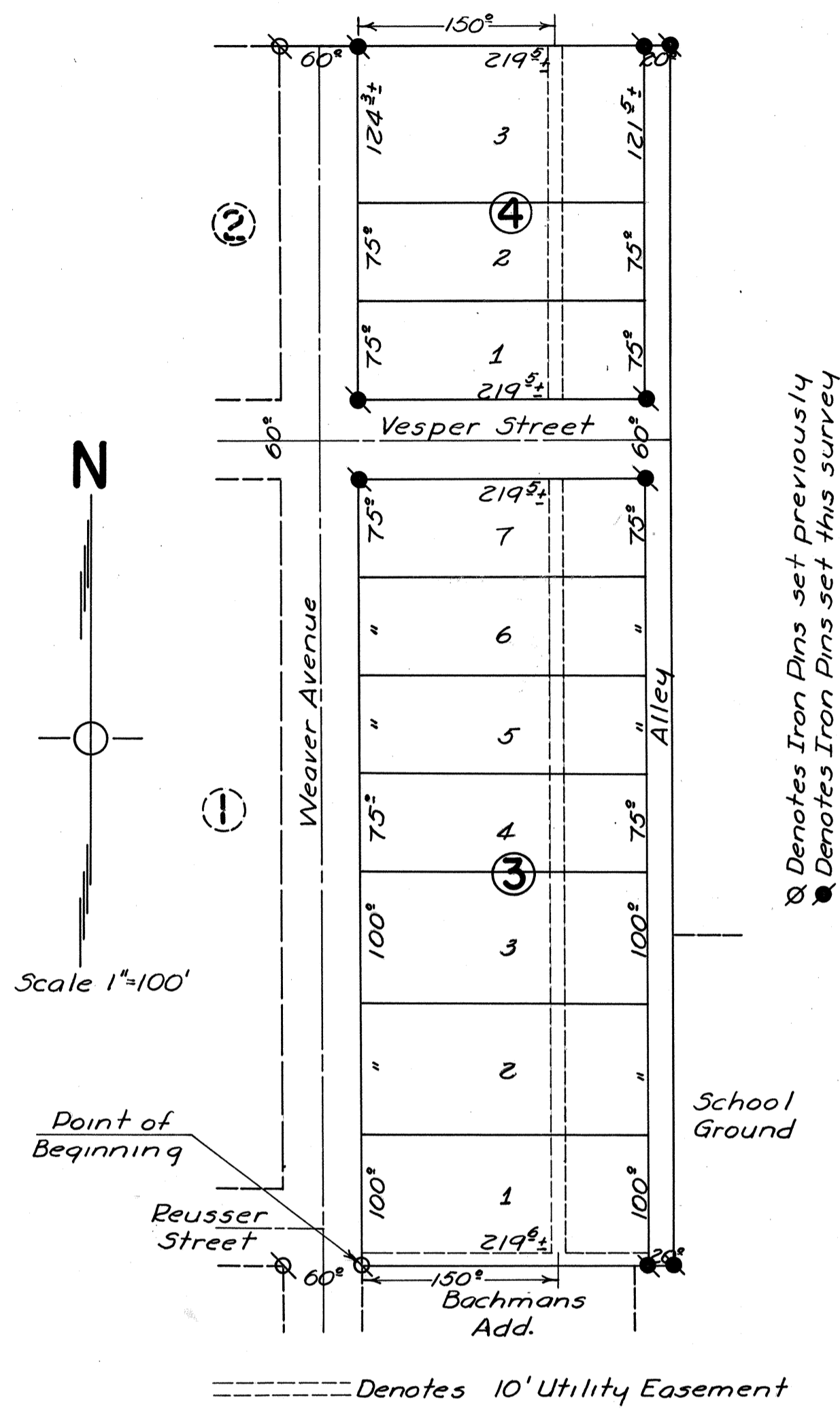


BLOCKS 3 & 4 REUSSERS ADDITION

HARVEY COUNTY KANSAS



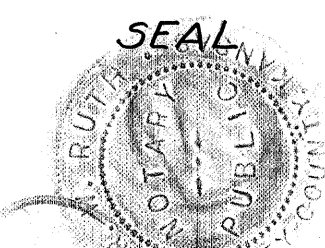

Know all men by these presents, that we M.E. Reusser and Irene Reusser his wife, both of the City of Hesston, Harvey County Kansas, do hereby certify that we are owners of the following described property; Beginning at a point 190 feet North and 420 feet East of the Southwest corner of the West One-Half of the Northeast Quarter of the Northeast Quarter of Section 16 Township 22 South Range 1 West; thence East 239.6 feet to the East line of the West One-Half of the Northeast Quarter of the Northeast Quarter of said Section 16; thence North 931.5 feet along the said East line to a point 200 feet South of the North line of said Section 16; thence West 239.5 feet parallel with the North line of said Section 16 to the East line of Weaver Avenue in the City of Hesston, Harvey County, Kansas; thence South 934.3 feet along said East line to the place of beginning, and that we have caused the aforesaid tract to be surveyed and subdivided into blocks and lots and streets and alleys of location and dimension as shown by the accompanying plat for the purpose of recording and conveying same by number of blocks and lots as shown by the aforesaid plat.
The street, alleys and easements are hereby dedicated to the public use and benefit.

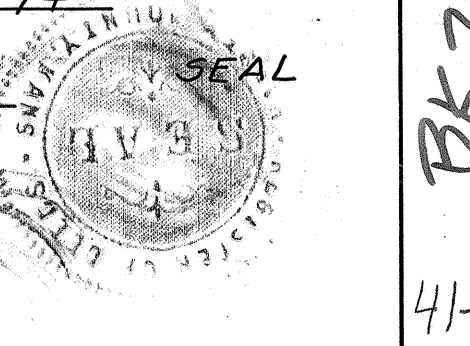
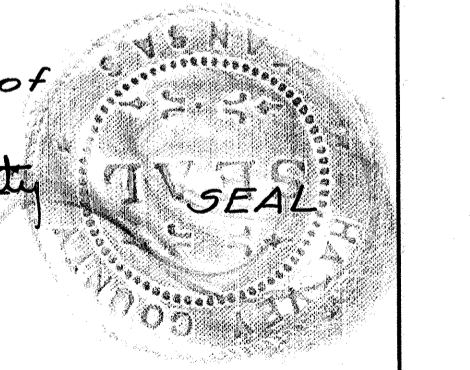
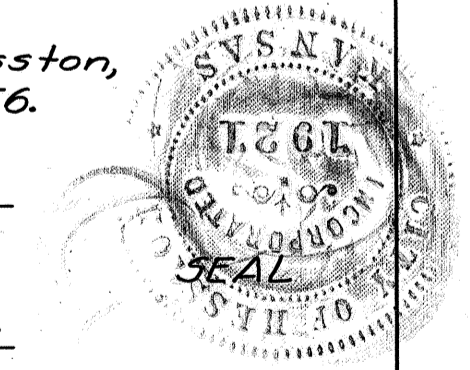
