The Ravinia District Update

Throughout the pandemic, the City has partnered with the Ravinia District SSA 17 property owners and business owners to promote the area and expand opportunities for pandemic-friendly dining, shopping, and services. In 2020, the Ravinia District hosted various safe, socially distanced outdoor events, including music, dining, fitness classes, and children's activities.

Visitors returning to the Ravinia District for Food Truck Thursdays will enjoy new streetlights installed in summer 2020 as part of a streetscape project funded through the *Ravinia TIF District*. The Ravinia District Special Service Area 17 (SSA 17) stepped forward to provide \$175,000 to fund and implement the street furnishings portion of the project, including benches, bicycle racks, and trash/recycling receptacles. The SSA represents a valuable private partner in helping realize the implementation of the streetscape plan. The new streetlights provide even lighting and comply with the City's right-of-way lighting standards and dark skies policies. New benches face away from the street to accommodate conversations better, direct attention to businesses, and address safety concerns.

In addition, the City's sponsor-a-planter program offers residents and business owners the opportunity to sponsor planters located throughout the Ravinia and Central Business Districts. More information is available at cityhpil.com/seasonalplanters.



May 24 - 25: Install brick pavers.

May 26 - 27: Pave new asphalt drive aisles

May 28: Install pavement markings to show new parking stalls.


May 28: Landscape restoration.

Mask Requirements for Fully Vaccinated People

On Monday, May 17, Governor Pritzker issued a new Bridge Phase <u>executive order</u>, bringing the State of Illinois' masking requirements in line with <u>CDC guidance</u>.

FAQs

Does the State of Illinois still require residents to wear masks if they have been fully vaccinated?

In most settings, fully vaccinated people no longer need to wear masks. However, there are specific exceptions to this guidance, and customers must respect masking requirements at businesses or other venues that may implement their own guidelines. When does the CDC require fully vaccinated people to be masked?

According to the CDC and the State of Illinois, fully vaccinated individuals are required to wear a face-covering:

- · On planes, buses, trains, or other forms of public transportation;
- · When in transportation hubs (airports, train stations, bus depots, etc.);
- · In congregate facilities (correctional facilities, homeless shelters, etc.);
- · In healthcare settings; and
- · When required by local businesses or workplaces.

When are people considered fully vaccinated?

People are <u>fully vaccinated</u> two weeks after receiving the second dose of either the Pfizer or Moderna vaccines or two weeks after they receive the Johnson & Johnson single-dose vaccine.

Are customers required to respect masking regulations in businesses, even if they've been fully vaccinated?

Yes. Both the Governor's *executive order* and *CDC guidance* allow business owners to implement more restrictive guidelines if they would like. Businesses may require all customers and employees to wear masks, including those who are fully vaccinated. Customers are encouraged to be respectful of these requirements and of fellow patrons who continue to wear masks.

What should unvaccinated people do?

According to the Governor's executive order, unvaccinated people over the age of two are required to:

- · Maintain social distancing from others in public settings
- · Wear a face-covering over the nose and mouth in public settings when a six-foot distance from others cannot be maintained

Funding Opportunities for Small Businesses Available Now Through American Rescue Plan

- Restaurant Revitalization Fund: Provides funding to help restaurants and other eligible businesses cover revenue loss up to \$10 million per business.
- Shuttered Venue Operators Grant: Provides grants to hard-hit of up to 45% of gross earned revenues
- In addition, the Illinois Small Business Development Center is partnering with the College of Lake County to offer several resources for small businesses using funding from the CARES Act.

Restaurant Revitalization Fund Applications Opened Monday, May 3

The American Rescue Plan Act established the Restaurant Revitalization Fund (RRF) to provide funding to help restaurants and other eligible businesses keep their doors open.

• The RRF will provide restaurants with funding equal to their

- pandemic-related revenue loss up to \$10 million per business and no more than \$5 million per physical location.
- Recipients are not required to repay the funding as long as funds are used for eligible uses no later than March 11, 2023.
- Priority in the first 21 days of the application window will be given to restaurants owned by women, veterans, and socially or economically disadvantaged groups.

Shuttered Venue Operators Grant Applications Open Now

The Shuttered Venues Operators Grant (SVOG) includes over \$16 billion in grants to shuttered venues. Eligible entities include live venue operators/promoters, museum operators, motion picture theater operators, live performing arts organization operators, and more.

- Eligible applicants may qualify for grants equal to 45% of their gross earned revenue, with the maximum amount available for a single grant award of \$10 million.
- \$2 billion is reserved for eligible applicants with up to 50 full-time employees.
- Venues or promoters who received a PPP loan on or after December 27, 2020, will have the SVOG reduced by the PPP loan amount.

Grant Program

The City of Highland Park has a matching grant program to assist restaurants and retailers with operational costs incurred to provide a safe environment for customers and staff in compliance with state and federal public health guidelines for the coronavirus pandemic. The program will accept applications from qualifying restaurants and retailers located and operating within a commercial building in Highland Park



with a net worth of less than \$2 million and generating less than an average of \$200,000 in profit per year for two years after taxes. Qualifying restaurants and retailers may apply for reimbursement of up to 50% of eligible expenses related to COVID-19 public health mitigations, to a maximum of \$10,000 for restaurants and \$5,000 for retailers, for costs incurred between August 15, 2020, and December 31, 2021, or until funds are depleted. *More information is available here*.
