## **OfficerID: Tdragicevich, Narrative**

On Tuesday October 26th 2010 at 238am I (Ofc. Dragicevich) responded to 1566 McDaniles for the report of domestic troubles between husband, and wife.

Upon arriving I met with Bob Crimo who was sitting in his truck in the drive way. Bob related that he returned home from work at 1215am., and had a verbal argument with his wife Denise. Bob related that he went upstairs brushed his teeth, then informed his wife he was going to bed. While in bed, Bob related that his wife (Denise) was "Trash talking". At this time Bob left the residence to go sit in his truck (approximately 30mins). Bob then contacted Denise (via phone) to let him back into the house. Bob again laid down to go to bed. Bob then related that Denise came into the room stating she needed to remove the lock from the bedroom door if he is going to stay in the house. After removing the lock from the door, Denise then knocked all of Bob's belongings off of his dresser, then asked him to leave. Bob then left the residence, at which point in time he contacted the non emergency number to file a incident. While explaining the incident, Bob related that Denise had hit him with a screwdriver on the left forearm leaving a small scratch (photos taken).

Officers attempted to make contact with Denise, with negative results. A message was left on Denise's cell phone to contact the department. At this time Bob drove to the station to complete a written statement of the incident. Bob refused to put in the statement regarding being struck by a screwdriver, and simply stated she didn't try to hit me with it, and "it's nothing."

At 409am I attempted to contact Denise via phone with negative results, message left.

Later in the day on 10/26/2010, Officer Curran made contact with Denise and a witness statement was completed by Denise regarding the incident, stating that it was Bob who started the argument, and that it was in no way physical. Denise made no mention of removing the lock from the door, or hitting Bob with a screwdriver.

## **OfficerID: Rwagner, Narrative**

**On 08-16-2010 at approximately 4:31am Officer Wagner and Bradish were dispatched to 1566 McDaniels Avenue for a verbal domestic in progress.**

**Upon arrival, Officer Wagner observed Robert Crimo and Denise Pesina-Crimo outside in front of their single family residence, separated but arguing loudly. Officer Wagner gave both parties verbal commands to calm down and separate further. Officer Bradish then arrived on scene and aided in their separation.**

**Upon speaking with Mr. Crimo he advised he had just returned home from work and discovered that his wife, Mrs. Pesina-Crimo was intoxicated. Mr. Crimo said an argument ensued over their failing relationship and began to escalate. Mr. Crimo alleged that at one point his wife had taken off her shoe and struck him on the head (no visible marks). Mr. Crimo advised he called Police before the situation escalated.**

**Mrs. Pesina-Crimo stated that she was upset from events earlier in the day when she felt disrespected and belittled by her husband. Mrs. Pesina-Crimo advised that she began drinking because of the comments.**

**Mrs. Pesina-Crimo further advised that the argument occurred as soon as her husband walked in the door. She explained that Mr. Crimo walked in, gave her a disgusted look, and began commenting on her "poor appearance."**

**After Officers determined that no evident physical contact occurred, Officers asked Mr. Crimo if there was another place where her could stay for the night. Mr. Crimo advised that he was able to stay else where and left the area.**

**Upon Mr. Crimo's exit Officers spoke with Mrs. Pesina-Crimo about options in dealing with her troubled relationship. Officer Wagner offered Mrs. Pesina-Crimo a domestic violence packet. She refused, stating she already received one a few days ago when Police were called to her residence for a similar situation. Officers encouraged the couple to seek marital counseling or separation to remedy their ongoing issues.**

## **OfficerID: Ddibasilio, Narrative**

On 6/12/11 at 0149 hours, Officer Bodden and I, Officer DiBasilio, were dispatched to 1566 McDaniels Avenue in reference to a suspicious activity complaint. Dispatch advised to meet with complainant, Denise Pesina-Crimo, regarding threatening telephone calls.

Upon our arrival, I met with Denise. Denise advised at 2215 hours, she received a text message from an unknown contact number, [REDACTED] stating, "Fuck you". At 0134 hours, she received another text message from the same number stating, "Wanna know what's wrong with her husband and I bet I will break her nose." Denise then called the number and a male answered the phone. Denise was not sure who she was speaking with, but the male told her, "You bitch I'm gonna break your nose."

While on-scene, Denise's story kept changing and her mood was very inconsistent.

Denise advised she recently changed her cell phone number because she has been having problems with unknown people calling her.

Earlier in the day, Denise advised she had a dispute with her friend, David Daniels, for an unknown cause. I attempted to contact David, but was unable to speak with him. I left David a voicemail message to contact me at the police department.

I had Denise complete a Written Statement, which she signed.

I completed a Grand Jury Subpoena Telephone Records form.

No further action taken.

Pesina stated William has done this in the past and that she had signed a no trespass notice against him but could not produce one. Pesina did not know the man's last name or address. Pesina could not confirm wheter it was the same man and appeared to be highly intoxicated while speaking with officers. Pesina changed her story multiple times stating the man was on her front lawn alone shining a flash light, then later stated he was running away with his dog down the block. Also on scene, Robert Crimo, M/W, ██████ stated he did not see this man on the property, but he did see a man walking down the block towards Deerfield Rd. with a dog, but could not confirm if it was "William." On 11/20/20 at 03:27 p.m. I, Ofc. D. Graff (#142), was dispatched to the Police Department lobby for a fraud report. Upon arrival I spoke with Denise M. Pesina who reports she applied and paid for a First Premier Bank credit card and never received it. She reached out to First Premier Bank who notified her the card was maxed out for \$700 and she owed the money. Ms. Pesina advised she never received the card and did not make the purchases. Ms. Pesina was advised the purchases were all in Chicago and she was told the card may have been taken out of the mailbox or taken in transit. First Premier Bank told her she needed to file a Police report since she was disputing the charges.

I contacted customer service (#800-987-5521) and was advised the card (account # [REDACTED] was activated, pin set up (#2134), and used 4 times on 11/14/20 in Chicago. Purchases of \$229.12 were made at Walgreens store #147 in Chicago & \$333.93 at store #5192 in Chicago. A purchase was also made at a BP gas station store # 97436 for \$9 and a South Chicago gas for \$40. Card already filed as disputed, they will send her affidavit but needed Police report. Dispatch advised Denise Pesina was in the lobby regarding some additional information for case #2020-18116. I spoke with Denise in the lobby who advised she had received some additional information from First Premier Bank security department member Janet. Janet gave Denise the phone number that activated the card of [REDACTED]

Denise also advised First Premier had sent her out a second card (account [REDACTED] since the first one was lost/stolen and that card also was activated and never received by Denise. The phone number used to activate that account was [REDACTED]

Denise advised she has already contacted an attorney who advised they will pursue this as soon as this hits her credit score. Denise has also filed complaints with the Better Business Bureau (case # 100182808) and USPS (report # 35964886). Denise advised she sent multiple e-mails to the CEO of First Premier Bank but has not heard anything back yet.

Denise also saw on the news an article about USPS employees being arrested and charged with stealing credit cards in the mail and contacted Samantha Chatman with USPS regarding that issue in case it is related.

Denise advised to freeze or put a fraud alert on her credit which she was given information for back in November. Also advised her to look to file a consumer complaint federally if the bank does not take back the charges. Nothing further at this time.
