



Good morning Mr. Nathan,

Thank you for your continued support and appreciation. We sincerely appreciate and value it.

The Public Portal is automatically updated every 24 hours by pulling the information directly from the member departments' records software. However, incidents typically take 1 week to appear in the portal. This is due to reported incidents having to be verified and investigated by the responding officer. Next, the officer types and submits a report which is reviewed by his/her immediate supervisor, then the Patrol Commander, and finally by the Records Department. By the time that all happens, especially if the officer is asked by someone in the review change to make any additions to the report, it takes about 1 week. We want to ensure info posted in the portal is accurate.

When the portal was being designed, the group of partner agencies that chose to participate met, discussed, and agreed upon what incidents would be posted. That is the list that you see on the left hand side of the web page. While it isn't easily changed without approval of the members, it will be reviewed from time to time for any opportunities for improvement. If you would like to see other categories added, please share them with me and I will take them to the group for consideration at the next review meeting.

With regard to the Synagogue threat, it would not appear on the portal with the current settings. However, the City of Highland Park posted the threat on its various media platforms, such as its Facebook page, shortly after the threat was received. We regularly do this with such incidents when there is a concern for public safety. Another option is to sign up for Smart 911 for emergency notifications from the City. You can learn more about <u>Smart 911 here:</u>
