In the meantime, please be aware that crisis counselors are available at the Crisis Text Line 24/7 by texting HOME to 741741. Families may also find this resource from the National Association of School Psychologists helpful in talking about violence with your children.

We are in communication with local agencies and we will share additional information later and tomorrow.

It goes without saying that yet another incident of gun violence has caused irreparable

My family and I were at the parade this morning at the corner of 2nd and Central Avenue. I walked up at about 10:12 AM and took 2 photos of my inlaws and wife and kids watching the parade (photos attached). Not too long after the photos I heard loud gunfire ringing out behind me from the right. I hit the ground and then could hear and feel a bullet ricochet past my right side before getting my family and running into Gearheads. I did not see the shooter, but directionally the sound seemed like it was coming from the rooftop of the Ross Salon.

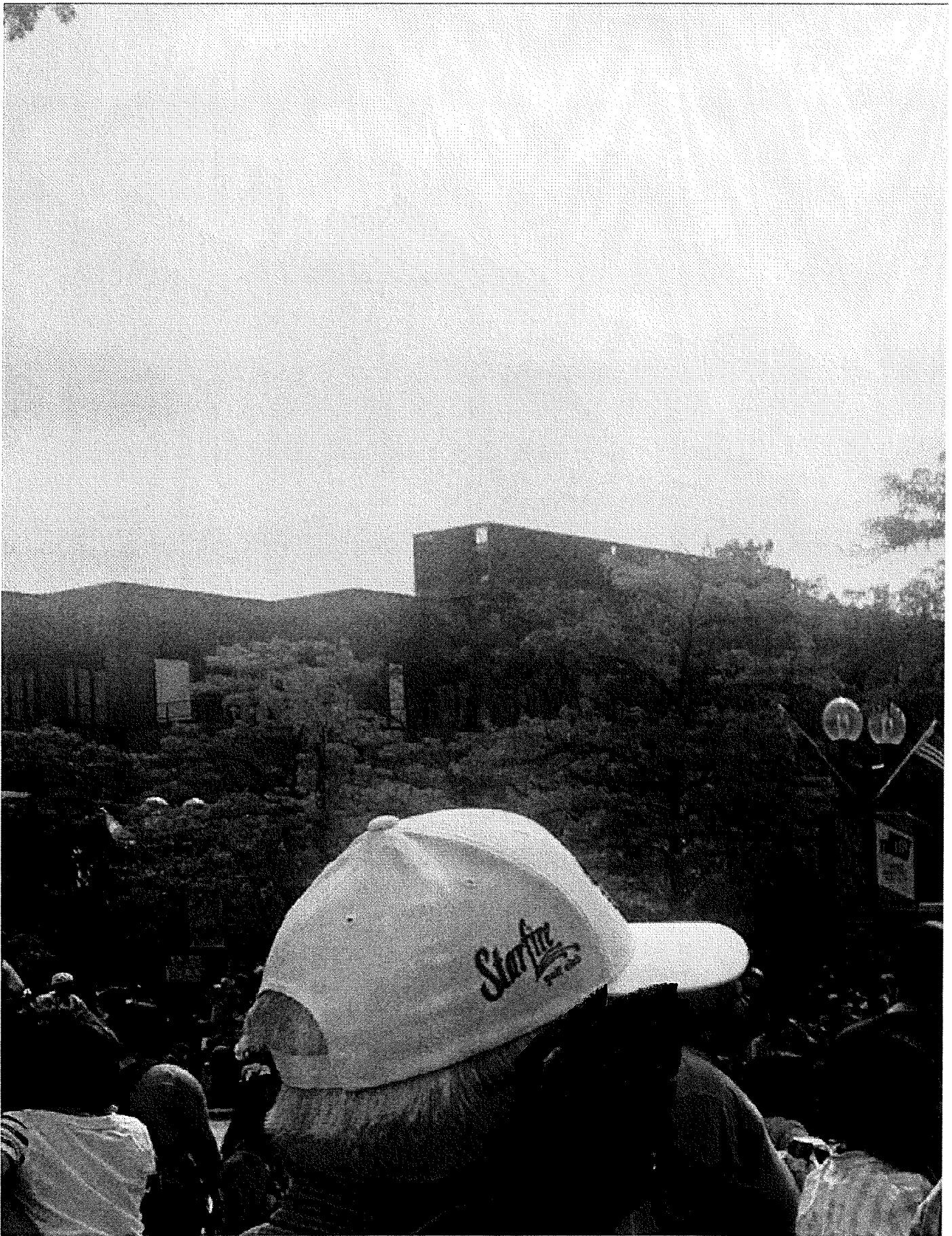
