We are families of previous mass shootings. We take NO ADMIN fees and ensure 100% of what is collected goes straight to those most directly impacted.

I was born and raised downstate in Illinois, went to college in Illinois, worked in Chicago for years. Dr. Blair is a graduate of the University of Illinois in Chicago.

We have families of the deceased with us who live in Illinois from both the Aurora, CO and NIU mass shootings.

We want to make sure that re-traumatization/re-victimization of families of the mass shooting there in Highland Park does not occur, and if there is no centralized VictimsFund, that will inevitably happen. Nonprofits like United Way and Red Cross are community-based funds. They do not give 100% directly to victims and previous mass shooting victims across this country are aware of this.

We have lived this experience ourselves and can guide you through the process.

ITC: Psychosocial training and support

Horrific shooting incident on nation's celebration day in Highland Park, IL deeply shocked the whole community—the ripple effect of this horrific incident impacts many in different ways. For many individuals and families this event will remain a traumatic experience of their life for long time and the community will need some time to recover as well.

Over the next few days, the response, both operational and psychosocial, will transition from the immediate phase to providing a mid to long-term response, requiring comprehensive coordination, deliberate planning of emotional support provision to various circles of impact along the timeline, including identification of needs for these phases and availability of recourses.

In light of the reality described above, and based on our experience in supporting the psycho-social response to multiple incidents in Israel and around the world, the following steps are recommended:

- Identification, mapping and scoping of needs of different groups of people
 impacted by the incident in various intensity (families that lost their loved ones,
 survivors, parents/children of missing and dead, community institutions such
 as schools, first responders and care-providers etc.) including the projection of
 those needs' development along time, including various time marks (end of
 forensic procedures, funerals, back to school, holidays and so on).
- Identification, mapping and scoping of psycho-social support recourses (it should be kept in mind that such a transition also comes with withdrawal of "helping hands" that will be so useful during the first days and gradual decrease in availability of outside help. Also the initial response always characterized by certain level of duplications and deficits as one, due to the fact that multiple organizations are "jumping in" to help, not always in most coordinated way.
- Development of mid and long term, detailed and coordinated plan for prolonged psycho-social response, based on development of common language, utilizing all available community recourses (not only mental health professionals), progressing from short-term interventions, targeting acute trauma to full rehabilitation, focusing on It on strength and resilience of the community and its members.

From our perspective and experience, the recommended way to deal with these challenges is via a comprehensive systematic community approach that enables all the local agencies and stakeholders, formal and informal, to share their knowledge and resources and integrate their actions in favour of the community so that a continuum of care can be created in a shared language and culture of services.



ITC is capable and willing to share our expertise and experience in psycho-social response following traumatic events (by conducting online and offline training sessions) on following topics:

- Augmentation of local experts' capacity in trauma focused care for individuals, families and groups including but not limited to -
 - Tools for provision of non-stigmatized direct care from the acute phase onwards, for individuals and families.
 - Diagnosis, triage and initial intervention principles, models and modules for Acute Stress Reaction (ASR) / Acute Stress Disorder (ASD) as well as Post Traumatic Stress Disorder (PTSD)
 - Trauma focused evidence based techniques
 - Practical skills on psycho-social interventions in traumatic stress situations
 - Identification, mitigation and management of compassion fatigue and burn-out symptoms amongst first responders and care providers
 - Treating grief and bereavement
 - Development of a continuum of services to deal with psycho-trauma and rehabilitation.
- Support in development of community resilience restoration plan, empowering
 and training the formal and informal leadership and professional services in the
 areas of health, welfare, education and community (including faith leaders) as
 well as local NGOs by training trainers and creating a cascade model of
 providing psycho education.
- Development and implementation of non-stigmatized emotional support mechanism and language to address the well being of first responders and care providers, that were and still are involved in incident, focusing on mitigation and decrease of burn-out and compassion fatigue levels among those.

- Psycho-social care providers psychiatrists, psychologists, social workers and therapists.

- NGO and volunteer based organizations administration and practitioners.
- Operators of Hotlines and other support services specifically established or utilize to provide response to current incident (including self-care practices).


Normative reactions to traumatic events

Following any traumatic event, that shatters one's routine and beliefs in life, it is natural to experience stress reactions that may feel different or more powerful than in everyday life Normal reactions to an abnormal situation



Circles of Impact

In this kind of a crisis, there are various circles of impact, where the most vulnerable/affected persons are the ones most directly exposed.



How to help children cope with grief and stress?

- Tell the truth about what happened.
- Be prepared for a variety of emotional responses.
- Be aware that your reactions and coping methods can be a model for your child.
- Help the child name their emotions and ensure them it's ok to feel this way.
- Be comfortable saying, "I don't know."
- Let the child grieve in his or her own way.
- Use relaxation techniques.

Reach out for professional help if...

- Symptoms of stress as a result of for help.
- The first 48 hours might be shocking, and any symptoms you may experience would be normal.
- If the symptoms last over a month following the event, please reach out to a professional for help.




- Intrusive thoughts and images,
 nightmares or flashbacks of the event.
- Emotional and physical reactions to the event while awake or dreaming.
- Avoidance and withdrawal, feelings of detachment and estrangement, loss of appetite, depression.
- Physical arousal, irritability or outbursts of anger, difficulty falling or staying asleep.

Normal reactions to an abnormal situation

Parents: how to recognize signs of distress in your child?

- Regressive behaviors such as: clinging, crying, bed-wetting, thumb-sucking.
- Aggressive behaviors such as: anger, risk-taking, impulsiveness.
- Avoidant behaviors such as: isolation.


No City personnel or officials were injured.

Dear Amy and Daniel,

Yesterday, a tragedy occurred in Highland Park. A gunman fired repeatedly into the Independence Day parade, taking six lives and wounding dozens.

The suspected shooter was taken into custody in the early evening, more than eight frightening hours after the shooting. Given that situation, we quickly decided to cancel both our 4th of July Parade and the evening concert and fireworks.

There really aren't words for this moment to express our condolences to those who lost loved ones or were otherwise harmed yesterday morning, to communicate our anger at the gruesome reality of gun violence in America in 2022, or to articulate how frightening it is for a town that treasures its communal public gatherings like 4th of July parades to grapple with the question of when we can ever be truly safe.

It feels as though our society is coming apart.

Let's start with the obvious: the ready availability and incomprehensible number of guns on our streets is a crime against public safety. Almost no other country has gun laws like ours, and no other country has a problem akin to ours. It's not a coincidence, and anyone who continues pretending to believe otherwise has blood on their hands.

Next: we don't yet have much information about the motive behind yesterday's crime, but there are at least some indications that it may be in part political or ideological. Political violence is playing an alarming role in America today, ranging from the enormously high-profile events of January 6, 2021, to the little-publicized threats that public officials endure on a far-too-regular basis. I hope it goes without saying that democracy is incompatible with the use of violence to resolve political disputes.

Finally: we are living in a time of intense anger and polarization, when disagreements escalate quickly and frequently. Obviously heated arguments are a far cry from yesterday's nightmare, but I do think there's a connection between our society's widespread and growing difficulty with constructive disagreement and these extreme acts of violence.

Let's also be clear-eyed about what's different about these times and what isn't. White supremacy sure isn't a new phenomenon in this country, and political violence isn't either. But today, white supremacists have digital tools they can use to target and radicalize young white men, who then get messages from mainstream sources that they interpret as encouragement, and furthermore have no trouble getting their hands on military-style weapons. Given that, the situation we find ourselves in should be no surprise.

It's obvious that we need dramatic change in all of these areas. The gun issue, while politically challenging, is substantively relatively straightforward. We know that policy changes can make a difference, and we need to demand that they happen quickly, and without being watered down to the point of ineffectiveness. And while municipalities and states must use every tool at our disposal, municipal and state borders are porous, so we absolutely need federal action as well.

The other problems we need to take on are more complicated but we have no choice but to try. We cannot leave any room in this country for politics of violence, and we cannot structure our public discourse in such a way as to orient ourselves toward maximum conflict. Democracy is quite literally a tool for non-violent collective decision-making, and when we can't count on that happening, everything else in society begins to break down.

Let me end on this same subject, but on a positive note. During yesterday's tragedy, many people and institutions stepped up, pitched in, and demonstrated just the kind of commitment to collective effort that we need. First responders from across the north suburbs and Chicago put aside their already-enormous holiday workload to help out and ultimately apprehend the suspected shooter. We owe them a great debt of gratitude.

The Evanston 4th of July Association, a group of dedicated volunteers, worked for months and months to plan yesterday's festivities, and then when the news came in from Highland Park, turned on a dime. Thanks to them for their dedication and hard work. Finally, I know that after two years of pandemic-induced parade cancellations, our whole community was excited about yesterday's planned celebrations. When circumstances changed, people quickly and generously cooperated with law enforcement and focused on supporting one another and staying safe. Thanks to all for coming together in such a painful and difficult moment.

We have a lot of progress to make but I am confident that we have the people, the heart, and the values to get it done. Let's get to work.

ITC: Psychosocial training and support

Horrific shooting incident on nation's celebration day in Highland Park, IL deeply shocked the whole community—the ripple effect of this horrific incident impacts many in different ways. For many individuals and families this event will remain a traumatic experience of their life for long time and the community will need some time to recover as well.

Over the next few days, the response, both operational and psychosocial, will transition from the immediate phase to providing a mid to long-term response, requiring comprehensive coordination, deliberate planning of emotional support provision to various circles of impact along the timeline, including identification of needs for these phases and availability of recourses.

In light of the reality described above, and based on our experience in supporting the psycho-social response to multiple incidents in Israel and around the world, the following steps are recommended:

- Identification, mapping and scoping of needs of different groups of people
 impacted by the incident in various intensity (families that lost their loved ones,
 survivors, parents/children of missing and dead, community institutions such
 as schools, first responders and care-providers etc.) including the projection of
 those needs' development along time, including various time marks (end of
 forensic procedures, funerals, back to school, holidays and so on).
- Identification, mapping and scoping of psycho-social support recourses (it should be kept in mind that such a transition also comes with withdrawal of "helping hands" that will be so useful during the first days and gradual decrease in availability of outside help. Also the initial response always characterized by certain level of duplications and deficits as one, due to the fact that multiple organizations are "jumping in" to help, not always in most coordinated way.
- Development of mid and long term, detailed and coordinated plan for prolonged psycho-social response, based on development of common language, utilizing all available community recourses (not only mental health professionals), progressing from short-term interventions, targeting acute trauma to full rehabilitation, focusing on It on strength and resilience of the community and its members.

From our perspective and experience, the recommended way to deal with these challenges is via a comprehensive systematic community approach that enables all the local agencies and stakeholders, formal and informal, to share their knowledge and resources and integrate their actions in favour of the community so that a continuum of care can be created in a shared language and culture of services.



ITC is capable and willing to share our expertise and experience in psycho-social response following traumatic events (by conducting online and offline training sessions) on following topics:

- Augmentation of local experts' capacity in trauma focused care for individuals, families and groups including but not limited to -
 - Tools for provision of non-stigmatized direct care from the acute phase onwards, for individuals and families.
 - Diagnosis, triage and initial intervention principles, models and modules for Acute Stress Reaction (ASR) / Acute Stress Disorder (ASD) as well as Post Traumatic Stress Disorder (PTSD)
 - Trauma focused evidence based techniques
 - Practical skills on psycho-social interventions in traumatic stress situations
 - Identification, mitigation and management of compassion fatigue and burn-out symptoms amongst first responders and care providers


Normative reactions to traumatic events

Following any traumatic event, that shatters one's routine and beliefs in life, it is natural to experience stress reactions that may feel different or more powerful than in everyday life Normal reactions to an abnormal situation



Circles of Impact

In this kind of a crisis, there are various circles of impact, where the most vulnerable/affected persons are the ones most directly exposed.



How to help children cope with grief and stress?

- Tell the truth about what happened.
- Be prepared for a variety of emotional responses.
- Be aware that your reactions and coping methods can be a model for your child.
- Help the child name their emotions and ensure them it's ok to feel this way.
- Be comfortable saying, "I don't know."
- Let the child grieve in his or her own way.
- Use relaxation techniques.

Reach out for professional help if...

- Symptoms of stress as a result of for help.
- The first 48 hours might be shocking, and any symptoms you may experience would be normal.
- If the symptoms last over a month following the event, please reach out to a professional for help.


Stress reactions can include-

- Intrusive thoughts and images, nightmares or flashbacks of the event.
- Emotional and physical reactions to the event while awake or dreaming.
- Avoidance and withdrawal, feelings of detachment and estrangement, loss of appetite, depression.
- Physical arousal, irritability or outbursts of anger, difficulty falling or staying asleep.

Normal reactions to an abnormal situation

Parents: how to recognize signs of distress in your child?

- Regressive behaviors such as: clinging, crying, bed-wetting, thumb-sucking.
- Aggressive behaviors such as: anger, risk-taking, impulsiveness.
- Avoidant behaviors such as: isolation.

The recent HIGHLAND PARK IL MASS SHOOTING took place less than 10 minutes from my home. We live down that parade's street in the next town over, Deerfield.




