I know that your department is likely incredibly busy fielding press inquiries right now so I'll try to keep mine brief.

Based on previous reporting the suspect in the fatal shooting on July 4th was identified using DNA evidence lifted from the weapon. I have two questions:

- Was this biometric data cross referenced against data previously uploaded to the NDIS or CODIS biometric databases?
- Is there any information the department can give me about when or why the suspect's biometric data was initially submitted to these biometric databases. I understand he had some previous interactions with law enforcement is that when the data was uploaded?

Thanks for all of your work in what I'm sure is a difficult time for the community.

Once again, People for Bikes ranks more car-centric, less bikeable cities above Chicago

Each year, Colorado-based nonprofit People For Bikes issues a bikefriendliness rating for over 700 cities worldwide. And each year, Chicago can be found near the bottom of the list, ranking below car-centric, bicycle-sparse metropolises like Houston and Los Angeles. 2022 was no exception; <u>the Windy</u> <u>City scored an embarrassing 16 out of 100</u> possible points for the second year in a row. The lousy rating is due to two factors: Chicago's high default speed limit and absence of a connected bicycle network of protected lanes.

Let's look at speed limits first. In <u>PFB's guide</u> to how cities can improve bike conditions and boost their rating, reducing residential speed limits to 25 mph or less tops the list. Traffic speed determines the risk of a fatality in collisions between drivers and people on bikes or on foot. Federal studies found that while pedestrians and cyclists struck by drivers traveling 40 mph have an 85 percent chance of dying, those struck at 30 mph have a 55 percent chance of surviving. However, the chance of survival increases to 90 percent if the driver is traveling at 25 mph. PFB City Ratings program director Rebecca Davies said lowering Chicago's default speed limit from 30 to 25 mph alone would boost our city's rating from 16 to 42, putting it in the top 15 of large U.S. cities.

Unfortunately, it looks like codifying policies for safe traffic speeds is an uphill battle in our town. Ironically the PFB scorecard was released on the same day <u>a razor-thin majority of alders</u> on Chicago's Committee on Finance voted to pass Ald. Anthony Beale's (9th) proposed ordinance to allow drivers to speed by as much as 9 mph with impunity to speed cameras. <u>The can has been kicked down the road</u> for now, but should Beale's ordinance pass, it would condone vehicle speeds of up to 39 mph on most streets, making what is a less-than-safe residential speed limit exponentially deadlier.

Regarding PFB's safe speed metric, Davies wrote, "given the relationship between speed and risk of injury or death, there is no justification for cities to allow cars to travel faster than 25 mph in neighborhoods."

The second factor dragging down Chicago's bike friendliness score is the city's piecemeal of protected bike lanes that abruptly start and stop, failing to connect riders to school, jobs, recreation, services, and major transit hubs. Kyle Whitehead, a spokesperson for Active Transportation Alliance, said the PFB score shows just how far Chicago has to go in making bicycling safe and viable for all levels of riders. "For too long, Chicago has taken a patchwork approach to building bike lanes, using paint or plastic to temporarily mark lanes before weather or car and truck traffic limits their usefulness. People riding may feel safe and comfortable for a few blocks of their trip, but they're inevitably dumped on to a dangerous street alongside high-speed car and truck traffic."

Shortly after the PFB ratings were released, CDOT announced that all flimsy plastic bollards, which provide no real barrier between cars and bikes on "protected" lanes, will be replaced by concrete curbs or parking-protected lanes

by the end of 2023. This is a huge step forward for public safety on existing bike lanes. However, Davies noted that the protections on many of Chicago's bike lanes, where they do exist, <u>end before intersections</u> where crashes are more likely to occur. These gaps make "low-stress" point-A-to-point-B trips by the PFB standards rare, even along routes where the city has made some investment in bicycle infrastructure. As the city upgrades existing protected bike lanes, it's worth looking at how extending protections can improve safety where bicyclists are most vulnerable.

The natural inclination when sifting through the PFB City Ratings is to pit cities against each other, sometimes with head-scratching results. I mean, is Las Vegas truly better for biking than Chicago? Whitehead wrote that it's best not to get hung up on the numbers but focus instead on the key issues in the evaluation. I tend to agree, but there is a peculiarity to Chicago's score that's worth noting. (Plus, this is a ranking system so comparing cities is kind of the point.)

The PFB City Rating is calculated with two numbers: a Network Score, which is heavily determined by the factors discussed above and weighted at 80 percent; and a Community Score, weighted at 20 percent and drawn from survey data of resident opinions on biking convenience and safety in their city. Among large U.S. cities, Chicago ranked dead last on the Network Score, getting a measly 5 points out of 100. However, it scored extraordinarily high on the Community Scale, scoring 62 out of 100: Fifth best of large US cities, right after Portland, Oregon. It's the largest discrepancy between the objective and subjective data of any city—worldwide, of any size—PFB rated.

Davies rightly pointed out that bias plays a big factor in who responds to surveys. Whitehead said the gap in the two scores reflects Chicago's "strong and growing community of experienced bicyclists"—those most likely to complete the survey. I would contend this strong and growing enthusiasm for

biking in the face of inadequate infrastructure and policies that favor moving cars quickly over public safety should be viewed as a mandate to city officials. Chicagoans deserve sufficient infrastructure for biking and safe streets for all users. We can do better.

What it was like riding Metra the day the U.S. gun violence epidemic reached Highland Park By John Greenfield on Jul 05, 2022 04:23 pm

Tragically, in recent weeks we've seen mass shootings motivated by racial hatred, political differences, mental illness, or all of the above, in diverse parts of the U.S. such as <u>Buffalo</u>, New York; <u>Uvalde</u>, Texas; and <u>Laguna Woods</u>, <i>California.

Sadly, Chicago regularly sees mass shootings as a result of interpersonal conflicts or gang rivalries. An incident where <u>a teen and four adults were</u> <u>wounded</u> early Monday morning two blocks south of the King Drive Green Line station in the low-income Parkway Gardens neighborhood may fit that category.

But <u>the mass killing later that day</u> at the Fourth of July parade in Highland Park, an affluent North Shore suburb, is further evidence that our nation's failure to get the gun violence epidemic under control is a threat to people from all walks of life. Hopefully this tragic event will help inspire the passage of federal gun control legislation, such as universal background checks and assault weapons bans, to keep Americans of all backgrounds and income levels safer.

Since Streetsblog Chicago's news lens is sustainable transportation, we asked contributor Igor Studenkov, who was heading to Highland Park yesterday on

behalf of another news outlet, to report on what riding transit in the northern suburbs was like on that tragic day. – John Greenfield, co-editor

The aftermath of the July 4 shooting in downtown Highland Park disrupted Union Pacific North Metra line service for hours, with service not fully restored until the suspect, 22-year-old Robert "Bobby" Crimo III was arrested.

<u>Crimo allegedly fired at Independence Day Parade marchers</u> from the rooftop of the Ross Cosmetics building at the corner of Central Avenue and 2nd Street, about three blocks northwest of the of the downtown Highland Park Metra station. Five people were pronounced dead at the scene, and two people subsequently died at a hospital. 38 people were injured, although most of them were released from hospitals after being treated for their injuries.

As law enforcement personnel tried to contain the crime scene, Metra trains were stopped just short of downtown, then got turned around. For four hours, there was no service north of Highland Park's Ravinia station, and when service was restored at 4:00 p.m., the trains bypassed downtown. However, around 7:00 p.m., after Crimo was arrested, service was fully restored.

I'm not entirely a stranger to Highland Park – I covered the city and some of the other nearby suburbs (mostly the other suburbs) for <u>22nd Century Media</u>. I've passed by the spot where Crimo allegedly spilled blood many times. I already had a weekend pass, and I ended up taking Metra after 4:00 p.m.

The snarled logistics

The Union Pacific North line runs between Chicago and Kenosha, Wisconsin, although only a handful of train actually serve the full length of the line, with most weekend trains only going as far as Waukegan, Illinois, the last major city before the border. During major federal holidays, Metra runs on a Sunday schedule, with the UP-N line only running nine trains in each direction.

The line has four stations in Highland Park – the eponymous downtown station, the Ravinia and Braeside stations serving the neighborhoods further south, and Ravinia Park station, which serves the Ravinia Festival outdoor concert venue when it's open during the summer. (Yes, it's confusing that the Ravinia station is not located at the Ravinia venue.)

Highland Park has four Metra UP-N line stations: (Downtown) Highland Park, Ravinia, Ravinia Park (where the music venue is located), and Braeside, at the Lake County / Cook County border. Image: Google Maps

On most days, the Highland Park station is something of a local transit hub. Pace bus routes <u>213</u>, <u>471</u> and <u>472</u> stop right next to the outbound platform, providing convenient transfers for passengers using the outbound trains. Route 213 largely parallels the line as far south as the CTA's Howard 'L' station, while Route 472 parallels the line as far north as the Ford Sheridan stop. Route 471 serves the section of Highland Park west of the railroad tracks and the the Deerfield and Northbrook communities further south. None of those bus routes run on Sundays and major federal holidays.

As law enforcement scrambled to respond to the shooting, outbound train 807, which left Chicago at 10:35 a.m., and inbound Train 814, which was scheduled to arrive in Chicago at 12:30 p.m., were stopped near downtown Highland Park. By 12:38 p.m., Train 807 dropped off its passengers at the Ravinia station and headed back to Chicago. Train 814 was similarly stopped at the Highwood station, the first station north of Highland Park,

Over the next hour, <u>none of the other scheduled trains ran</u>, with Metra recommending riders use the Milwaukee District North Line, which partially parallels the Union Pacific North line, instead. Eventually, Metra did run some UP-N trains as far as the Ravinia station, but didn't run any trains north of Highland Park.

Watching these service interruptions unfold on Twitter, it occurred to me that, if this had happened on a weekday or or Saturday, Pace might have been able to provide connecting service by rerouting Routes 213 and 472 away from Highland Park. But, as things stood, riders from north of Highland Park had to figure out their own way to reach their destinations, and anyone who had to get north of Ravenia wasn't much better off.

At around 3:30 p.m., Metra announced that through service would resume after 4:00 p.m. The trains would skip the Highland Park station, and because they would have to slow down, Metra warned that there would be delays.

Riding Past Highland Park

I took outbound Union Pacific North Train 419, which would normally be the second outbound train to serve Kenosha, leaving the Ogilvie Transportation Center in downtown Chicago at 4:35 p.m. My plan was to take it as far as the Lake Forest station (Lake Forest is another North Shore suburb about 7 miles north of Highland Park where Crimo was later apprehended), switch to the inbound Train 822, which would normally run express to Highland Park, disembark at Ravinia and maybe walk toward downtown, 1.5 miles away. Given the delays Metra mentioned, I was prepared to change plans on the fly.

On my outbound trip, a minor track fire at Evanston's Davis Street station platform delayed the train by about 15-17 minutes. Still, I was able to switch trains with a few minutes to spare.

Both on the way to Lake Forest and on the way back, I was struck by how still downtown Highland Park looked. By that point, social media was filled photos of folding chairs and other furniture that got left behind as people ran, but seeing it all lined up, even if from the window of a moving train, was something else entirely. When my inbound train crossed Central Avenue, the police were still there blocking traffic. There was no one on the street except the cops, and the parking lots were strangely empty.

When I disembarked at Ravinia, the first thing that stuck me was how eerily quiet it was. Most of the businesses would have been closed anyway, but at first, I didn't see anyone walking around at all – just cars passing by. The stillness was only interrupted by a whirl of the helicopters overhead and the sirens blaring at the distance.

I was reminded of the time I visited Ravinia <u>during the height of the pandemic</u>. There was the same quiet stillness, and the same lack of people.

I abandoned any thought of walking downtown because I was worried that I wouldn't be able to make the next inbound train. That would mean I'd have to wait for the final inbound train of the night, which wouldn't get there until 10:37 p.m.

But as I walked around, the helicopters stopped flying, and I saw more and more people walking around. Just a handful of dog walkers here and there, and a family walking home. But as time wore on, I saw more and more people. By the time Metra announced that the service would be restored, I saw a couple taking their toddler out for a walk before they went to see the arriving inbound train.

As I'm writing this, Pace hasn't announced whether it would make any changes in light of the tragedy. I assume that its service would be up and running. Even amid death and trauma, people still have places to get, and public transit will, hopefully, still be there to serve them.

Based on the recent benchmark verification shots recorded yesterday, it looks like the shots are close to NAVD88 which is compatible with our HP GIS system topography datum. And I am adding the known difference of 0.25 ft. (3 inches) to these shots to match the NGVD29 HP- Aero-Metric Engineering bench mark elevations. Originally I am getting big elevation discrepancies and I realized you set the Ranger 7 rod height to (2 meters) 6.56 usft. I reset it as when I measured the rod height to the base of the SP85 head mount, it is only 5.75 usft (69 inches).

Let us know the link to the delivered survey equipment (SP-85 and Ranger 7) recent user manuals.

Hope you are well during this difficult time as our State grieves with the Highland Park community. Reaching out to share a few updates from ISP regarding the Highland Park shooting earlier this week. Please let me know if there is <u>anything</u> we can be helpful with.

Gubernatorial Disaster Proclamation signed on July 5, 2022:

Highland Park Disaster Proclamation

In addition, the Governor will be ordering all persons or entities governed by the Illinois Flag Display Act to lower flags from July 5, 2022 to July 9, 2022, in honor of the lives lost in Highland Park. This will be released later today.

PUBLIC DETAILS FROM ISP

In September 2019, ISP received a Clear and Present Danger report on the subject from the Highland Park Police Department. The report was related to threats the subject made against his family. There were no arrests made in the September 2019 incident and no one, including family, was willing to move forward on a complaint nor did they subsequently provide information on threats or mental health that would have allowed law enforcement to take additional action. Additionally, no Firearms Restraining Order was filed, nor any order of protection.

At that time of the September 2019 incident, the subject did not have a FOID card to revoke or a pending FOID application to deny. Once this determination was made, Illinois State Police involvement with the matter was concluded.

Then, in December of 2019, at the age of 19, the individual applied for a FOID card. The subject was under 21 and the application was sponsored by the subject's father. Therefore, at the time of FOID application review in January of 2020, there was insufficient basis to establish a clear and present danger and deny the FOID application.

In our continued investigation into the shooting in Highland Park on July 4, 2022, the Illinois State Police (ISP) looked into the criminal background of the individual charged in the crime.

The individual passed four background checks when purchasing firearms, through the Firearms Transaction Inquiry Program (FTIP), which includes the federal National Instant Criminal Background Check System (NICS):

- June 9, 2020
- July 18, 2020
- July 31, 2020
- September 20, 2021

The only offense included in the individual's criminal history was an ordinance violation in January 2016 for possession of tobacco.

ISP has no mental health prohibitor reports submitted by healthcare facilities or personnel.

The September 2019 Clear and Present Danger report made by the Highland Park Police Department was made in response to threats allegedly directed at the family, but the report indicates when police went to the home and asked the individual if he felt like harming himself or others, he responded no. Additionally and importantly, the father claimed the knives were his and they were being stored in the individual's closet for safekeeping. Based upon that information, the Highland Park Police returned the knives to the father later that afternoon.

ISP will continue to provide as much information as possible in an effort to be fully transparent.

GOVERNOR'S STATEMENT

Unfortunately, every time a mass shooting occurs it serves as a stark reminder that our gun laws often fall short of the rigorous standards that feel like common sense to most Americans. I call on all Illinoisans to learn about and use the Illinois Firearm Restraining Order Act already in law to alert authorities to dangerous individuals with guns. My administration will work with the General Assembly to ensure we take on the gun lobby and do everything we can to further strengthen our gun control and red flag laws. While I support an assault weapon and high capacity magazine ban at the state level, we urgently need federal regulation on the weapons of war and high capacity magazines that are used only for mass murder. Illinois is not an island, and even with the some of the strictest gun laws in the nation, our state is only as safe as the state with the weakest laws—many of which border Illinois.

Again, please let me know if we can be helpful with anything. Sending my best during this time. Thank you.

I am a retired child and adolescent psychiatrist. I was brought up in Highland Park, and have brought up my children in Highland Park. We were at the parade on Monday, but we were far away from the active site and are all OK. After the Laurie Dann shooting in 1988, the Winnetka Public schools put together public meetings in each of the Hubbard Woods School classrooms for parents and children to get together and share their experiences. I participated in the staffing of those meetings.

I know that was a very different event at a different time in our history, but just like then, there is a lot of information being distributed in the news media about how to react to your children's understanding of what went on. I think it is always a good idea for the people that were directly involved to have an opportunity to be active in asking

questions rather than just getting somewhat generalized information passively.

If you decide the City of Highland Park should sponsor one large, or many small group meetings to talk about experiences of that day with the intention of healing and re-establishing the sense of community, I would be happy to help out in anyway I can.

Political conversations can come at a later time, but for now healing should be foremost on everyone's mind.


We had to do some research on our end and ask out counsel about the statute of limitations for things in collections. This is the response received from our corporate counsel.

"There's a new state law (effective last summer) that sets a 7-year statute of limitations for lawsuits to collect debts arising from municipal code violations. That would affect collecting judgments for administrative hearing fines. It may not affect invoices for other (non-Code-related) debts.

We can still try to collect debts after 7 years, but we would not have the ultimate ability to sue the debtor."

So, we do not have a limit on when we can pursue debt but we cannot sue the debtor after 7 years.



Hello my name is Dhruv Mehrotra and I am a reporter with the Center for Investigative Reporting. I know that your office is likely incredibly busy fielding press inquiries right now so I'll try to keep mine brief.

Based on previous reporting the suspect in the fatal shooting on July 4th was identified using DNA evidence lifted from the weapon. I have two questions:

- Was this biometric data cross referenced against data previously uploaded to the NDIS or CODIS biometric databases?
- Is there any information the department can give me about when or why the suspect's biometric data was initially submitted to these biometric databases. I understand he had some previous interactions with law enforcement is that when the data was uploaded?
