Attached, please find a photo of the shorts I was wearing during the parade. When I made it back to my Brother-in-Law's house ([REDACTED]), I noticed these odd holes in my shorts. I am unsure if these are caused by the shooting, or by diving on the ground. I have not washed the shorts yet, and could send them to you if they would be at all helpful.

I want to offer my most sincere thanks and love to your fine Police and Fire Department personnel! Firefighter Knicks (sp?) was kind to my young daughters before the parade started, and then miraculously helped my Mother-in-Law after she was injured.

My family is forever in your debt, and are so thankful for your bravery and service!

Dear Officer Neuman,

I called the non-emergency number about what may have been a benign incident earlier today but it struck me as odd. I live on [REDACTED] A young white male shortly before 10 am rang our bell and I answered. He claimed he was doing pest control and claimed he could rid our house today of wasps or pests. I asked him to leave info and that I was busy – my dog was barking – he commented “quite the guard dog.” He had an ipad or some device and took down info but said he had no flyer etc. I asked what company he was with – he showed a badge Aptive Environmental and I asked where his truck was and he claimed it was around the corner. My husband and I left shortly thereafter on our bikes for the parade but saw no truck in our vicinity and the young man was knocking on another neighbor’s door. This may be innocuous. We asked our neighbor who has Nest to review video footage and they captured the attached video.

My family and I were at the parade this morning at the corner of 2nd and Central Avenue. I walked up at about 10:12 AM and took 2 photos of my inlaws and wife and kids watching the parade (photos attached). Not too long after the photos I heard loud gunfire ringing out behind me from the right. I hit the ground and then could hear and feel a bullet ricochet past my right side before getting my family and running into Gearheads. I did not see the shooter, but directionally the sound seemed like it was coming from the rooftop of the Ross Salon.

I know this photo is facing the opposite way towards Walker Brothers but the message I just read on CNN said to send any and all videos/photos that we have to help corroborate evidence. I hope this helps somewhat with the investigation.

Apologize for not sending sooner but we've been helping our kids deal with all of the trauma from today.

Thanks to all of the brave heroes that responded today. My family and I are forever grateful.
