




Claiming to be an "ally" is easy. The hard part is the follow through.

**Tech workers call on their employers to end data tracking that could fuel abortion criminalization.** Big Tech employees are pressuring their employers to address whether the data they collect could be used to aid in state-level abortion prosecutions following the fall of *Roe v. Wade*. Employees at Google, Amazon and Microsoft are organizing petitions, issuing statements and speaking out on internal message boards in favor of stronger data protection for users, the Washington Post reports. Among the actions, the Alphabet Workers Union, a collection of Google employees and contractors, made a public statement calling for more action from the company. "What users are concerned about, in light of this ruling, is that Google will pass information on their searches, communications, and location history to law enforcement and that this data will be used to criminalize those seeking abortions," Parul Koul, a Google software engineer and member of the union, told the Post. "Google has completely failed to address this concern. We demand that Google refuse to store any data that could be used to prosecute users in the U.S. exercising their bodily autonomy."

**"We're here for you" has morphed into "we're watching you."** Although the U.S. was still recording more than 100,000 new daily coronavirus cases last week, many employers are clearly eager to move into the "post-COVID" workplace — and a growing number are essentially spying on their employees in a bid to pressure them to return to the office. An anonymous employee at a major U.S. bank came forward to Business Insider to describe just such a toxic environment where employees toil nervously under Big Brother's watchful eye. The employee, who spent 15 years at the bank and has since resigned, has a child too

young to be vaccinated and did not feel safe returning to a physical workspace. But the company is tracking ID swipes to see who's coming into the office and who isn't, while software installed on company-owned computers keeps a record of how employees fill their days — including how long they spend on Zoom, writing emails and talking on the phone. "Many companies track data, and I understand that I work in a highly regulated industry. The real problem for me is who can access the data — we fear our managers can look at it at any time," the employee told Insider. "When employees first found out about the tracking, we felt panicked. We started questioning if we did something to deserve this when we hadn't. The hardest part for me was seeing all of my colleagues go into fear mode." Tesla is also reportedly tracking office attendance by monitoring how often workers use their badges to sign in, and a survey released earlier this year indicates that up to 60 percent of employers now use some sort of tracking software to keep tabs on their employees.

**What everyone can learn from leaders of color.** Their assets go beyond experiences of oppression or marginalization to include the connection, meaning, and joy they can draw on from their respective cultures and communities, Darren Isom, Cora Daniels and Britt Savage of the Bridgespan Group recently observed in the Stanford Social Innovation Review. To better understand the relationship between leadership and identity, the team of three talked to 25 leaders of color across the philanthropy and nonprofit space and conducted a review of recent leadership literature. They also created a podcast, *Dreaming in Color: Creating New Narratives in Leadership*, to host conversations with leaders of color discussing how the issues of identity and leadership intersect. "Overall, our research identified several noteworthy assets, insights, and themes that many of these leaders of color share," they wrote in SSIR. "These assets can often be critical for social change. We hope this prompts the sector to rethink what the norms of good leadership might look like if the sector valued the assets of leaders of color — indeed, if it placed those assets at the center of the sector's leadership norms." **Count at least one Major League Baseball player who is taking a stand on gun violence.** The latest mass shooting in the Chicago suburb of Highland Park has weighed heavily on Liam Hendriks, a relief pitcher for the Chicago White Sox. "I think the access to the weaponry that is being kind of used in these things is — something needs to change," Hendriks said after the White Sox played on Monday evening. "Something needs to be done. Something needs to happen because there's way too many people losing their lives. And it's not only about the people who lose their lives. The families of that, the tragedy they go through, the entire community when people are concerned about leaving the house, concerned about doing the day-to-day things of going to work or any number of these things. We really need to reflect on what's going on." Previously, Hendriks has spoken passionately on other social issues, such as his support for the LGBTQ community — in fact, after he became a free agent in 2020, he asked potential teams if they had a "Pride Night" during the regular season. He also spoke out on the U.S. Supreme Court's recent decision to overturn *Roe v. Wade* and was flanked by a T-shirt in his locker stall that read "Stars & Stripes &

Reproductive Rights” when he made how he felt about gun violence clear to reporters.

**Under fire from critics, the index used to measure sustainability in the fashion sector is being suspended.** It has been a rough year for the Higg Index, one of the fashion industry's best-known sustainability rating systems. Reporting from the New York Times drew light on the Index's preference for synthetic materials made from fossil fuels, while the Intercept called out its links to the big players in the industry that it is meant to assess. The government of Norway is even considering a ban on the Index after its consumer watchdog raised greenwashing concerns. In the latest news, the Sustainable Apparel Coalition, which oversees the Higg Index, is taking the consumer-facing portion of the rating offline and says it is "expediting an independent review of the system's data and methodology," reports Amanda Shendruk of Quartz. While certifications like Higg have proliferated as consumers continue to seek out more sustainable products, critics say they fail to address root problems like over-consumption and actually distract from the fashion industry's environmental concerns. "Certification in general is sort of this false promise, and it is this license to greenwash," George Harding-Rolls, a campaign manager at the nonprofit Changing Markets Foundation, told Quartz.




Dear Mayor Roterer,

### **When Scary Things Happen: Talking to Children**

#### **"CHECK IN WITH YOURSELF, FIRST**

Before talking with a youth, check in with yourself (How am I feeling? What do I need?) so that you are calm and grounded during the conversation. Just as youth have feelings about these experiences, so do adults. You might feel scared, worried, overwhelmed, angry, helpless, sad, and/or concerned. You might feel distracted, scattered, confused, or even numb. These feelings, in both adults and youth, are completely normal following a traumatic experience."


Several community prayer vigils have already taken place. For those interested, a few more are scheduled for today and tomorrow:

## **Approved an annexation agreement with Allstate Corporation and Dermody Properties for redevelopment of former Allstate campus**

The Village Board unanimously approved an annexation agreement with Allstate Corporation and Dermody Properties that sets up the annexation of 290 acres into the Village of Glenview.

The Board also preliminarily approved the development plans proposed for the site and will give final consideration at its July 19 meeting.

The annexed area, formerly occupied by the Allstate campus, is on the far west side of the Village, west of the Tri-State Tollway. Most of the area was previously in unincorporated Cook County, and a 36-acre parcel is being disconnected from the City of Prospect Heights.

Last year, Allstate announced plans to sell portions of its corporate headquarters to Dermody Properties, a national developer with intentions of reinventing the property to a state-of-the-art logistics campus.

The image below shows an aerial view of the annexed land looking east. The area bordered in red is the land to be redeveloped by Dermody. The area in yellow will be retained by Allstate.

A fiscal impact study projects the development will generate more than \$134 million in new property tax revenue for local jurisdictions over the next 17 years. School Districts 31 and 225 stand to receive more than \$90 million in new revenue. The Village of Glenview and Glenview Public Library stand to receive more than \$15 million in new revenue during that span.



Hello Amanda,

My name is Samah Assad and I am a journalist with CBS Chicago. I'm working with my colleague Megan Hickey (cc'd) on a story airing tonight and we have some questions for Highland Park police about Crimo's past encounters with the agency.

At the time of the 2019 encounters, Illinois' red flag law was in place and gave law enforcement agencies the authority to file a petition with a court for a firearms restraining order without family of the individual filing a complaint or pressing charges. In this case, the Illinois State Police said because an order wasn't filed, that in part wouldn't have allowed ISP to take any action when the FOID card application was submitted.

Is someone available from the police department to talk to us about this today? We want to know, was the Highland Park Police Department aware of the red flag law and the agency's ability to petition the court for an order after the 2019 suicide attempt and threats made by Crimo? If so, why did the police department choose not to file an order based on the evidence it had from those two encounters?

Whether you were on site or watching the news unfold at home, we understand how traumatic the events of today have been on our City of Highland Park family. I am in awe and incredibly appreciative of the swift work that our emergency responders undertook when shots were fired in the business district. Police, Fire, Public Works, Admin and other employees as well as the community quickly worked to provide aide to individuals on the scene and police personnel immediately began the investigation which has now led the person of interest in custody. We are grateful to the immediate and on-going support from the FBI, Lake County Major Crimes Task Force, State, area law enforcement agencies and numerous other agencies and organizations.

***First Responders Wellness Center will be on site at West Ridge Center, 636 Ridge Road at 10 AM, July 5*** to provide trauma support and counseling to City Staff and the City Council as well as for our Government Partners. ***All team members are welcome and encouraged to attend if comfortable.*** Please note that the opening session at 10 AM is designed specifically for those that were on the scene today. Attached are three handouts for reference and below is the schedule for services.

- **10am, West Ridge Center – All team member who were at the Parade**
- **11:30am, West Ridge Center - All team members who were in Highland Park today**
- **12:30pm, West Ridge Center – All team members who would like additional support are encouraged to meet individually with a counselor from First Responders Wellness Center**

Additionally, communitywide counseling services will be taking place at the High School in a joint effort by the City, Park District, and School District 112 and 113 from 9:00 to 2:00. No appointment is necessary, but only the Vine Street entrance will be open. Anyone who is not a current District 113 student or staff member who wishes to take advantage of counseling services will need to have valid State identification to be cleared to enter the school, which is the school's standard procedure for visitors.

Human Resources will be sending out information on additional support options in the coming days.

### **COPING AFTER A CRITICAL INCIDENT:**

- Try to slowly get back into your normal routine
- Do healthy things for your body (eat fruits, vegetables, whole grain, beans), exercise (30 min. a day), & sleep (8 hours)
- Grounding, practicing being present in the here and now (Use all 5 senses)
- Avoid excesses such as food, alcohol, shopping, gambling, exercise, etc.
- Socialize with others & Talk about your feelings with others you trust
- Try therapy and/or spiritual counselors
- Have fun, read, play, and stay involved in your hobbies
- Volunteer or participate in other community activities to reduce isolation
- Watch comedies or look at [www.sunnyskyz.com](http://www.sunnyskyz.com), a positive upbeat online news media
- Look at [www.common sense media.org](http://www.common sense media.org) for guidance on what movies, TV shows, cartoons, that could be triggering for your situation. Common sense media reports on positive message, positive role models, violence, sex, language, drinking, drugs, and smoking, and consumerism.
- Turn Media off & Take a Break: You may want to know what is happening with your critical incident, but the updates can also add distress. Consider if you truly want to know or not, if so, then give yourself time limits.

### **SIGNS YOU MAY NEED MORE HELP:**

- Having symptoms that are getting worse or staying exactly the same since the incident.
- Difficulties with not thinking about the event and all the "what if's..."
- Depressive symptoms such as sadness, worthlessness, lack of energy, social withdrawal, low self-esteem, increase/decrease of sleep or appetite, indecisiveness, unresolved grief, and/or poor concentration
- Anxiety Symptoms such as excessive or unrealistic worry, difficulties controlling worry; physical tension (i.e. muscle tension, restlessness, shakiness); autonomic hyperactivity (i.e. heart palpitations, shortness of breath, dry mouth, nausea); hypervigilance (i.e. feeling on edge, difficulties concentrating, trouble falling or staying asleep, irritability), sadness, intrusive memories, poor sleep, anxiety, guilt, etc.
- Trauma Symptoms such as intrusive, distressing thoughts related to the traumatic incident, avoidance of reminders of the incident, detachment, hypervigilance, and arousal and distress when reminded of the incident.

- Symptoms that are negatively impacting your mood, thoughts, or daily functioning
- Having thoughts of death, suicide, or hurting oneself
- Not being able to do your job/school or take care of oneself or significant others
- Substantial decrease or increase of sleep, food, and/or alcohol or other substances

### **COPING STRATEGIES:**

- Tactical breathing: inhale for 3 counts, hold for 3, exhale for 3 counts to reduce stress.
- Use Calm, Headspace, or another phone app to practice guided imagery & meditation.
- Increase and use your support system. You are not alone, everyone suffers.
- Wallpaper: Put happy pictures on your phone of family or vacations for reminders of happy times
- Exercise Regularly: Gym, walk, play with kids, sports, etc.
- Move: Get out of your couch, draw, listen to music, walk around the block, visit a park or a nice view.
- Use scented candles, oils, or other fragrances that are calming at home. Consider a nice smelling air freshener in your office.
- Go to therapy and talk with a trauma counselor.
- Concentrate on what you have & appreciate it.
- Do something nice for someone else: Anything from opening a door to a smile.

### **SLEEP TECHNIQUES:**

- Lie down to sleep only when sleepy.
- Do not use bed for any other activities like TV, reading, listening to music, etc. only for sleeping.
- Get out of bed if sleep doesn't arrive soon after retiring (approx. 30-40 min)
- Try to set a consistent sleep-wake cycle. No napping, when possible.
- Restrict excessive liquid intake prior to bed & Avoid spicy late-night snacks or any late-night eating.
- Exercise daily but not 3-4 hours before bedtime.
- Minimize or avoid caffeine, alcohol, tobacco, and any stimulants.
- Do not use caffeine or any stimulants a minimum of 4-6 hours before going to bed.
- Try to avoid TV 1-2 hours before going to bed and avoid news or other intense material prior to going to bed.
- Make the bedroom colder, use brand new sheets, and darken your room.
- Try Chamomile, Valerian Root, Lavender, or Lemon Balm Teas.
- Eat Melatonin rich foods such as pistachios, tomatoes, tart cherries, walnuts, almonds, spinach, and bananas.

## **WHAT IS TRAUMA?**

A traumatic incident is when a person is exposed to an actual or threatened death, serious injury, or sexual violence in one of more of the following ways: 1) directly experience, 2) witness it, 3) learn about is occurring to a close family/friend/co-worker, 4) experienced repeated or extreme exposure to aversive details.

### **EVENT RISK FACTORS that increase difficulties in handling the trauma:**

- 1) Unexpected
- 2) Feeling unprepared or vulnerable
- 3) Unexpected consequences
- 4) Alone or feeling of being alone
- 5) Personal history with victim/offender/witness
- 6) Increased personal/current stressors
- 7) Current substance abuse or mental illness
- 8) Intentional act committed by another
- 9) Being near, highly exposed, and spending a long duration near or in the trauma
- 10) Victim is a child or vulnerable population
- 11) Man-made incident
- 12) Atrocity, brutal, or shocking
- 13) Victim or witness of multiple traumas
- 14) Inability to find any meaning or reason
- 15) Feeling that you did not handle the incident well

### **What you can do:**

- 1) Understand common trauma reactions & that there is not something wrong with you
- 2) Talk with others who are safe/Increase your social support/Be with others
- 3) Name your emotions & acknowledge them
- 4) Expect unwanted emotions (i.e., crying spells, anxiety in crowds)
- 5) Grief can take a long time; give yourself time to recover.
- 6) Do not judge yourself negatively, you survived! Accept that you have feelings—feelings are not wrong, only what you do with your feelings can be wrong. You have a right to feel both negative and positive emotions.
- 7) Do not immerse yourself in the trauma, limit your exposure, when possible, avoid a lot of media and social media.
- 8) Try to get back into your normal routine slowly.
- 9) Use deep breathing, meditation, yoga, or other things that are calming to you.

- 10) Self-care: Eat healthy, prioritize sleep, shower, etc.
- 11) Exercise
- 12) Do what you enjoy, if you are happy that does not suggest you are okay with what occurred.

## **Critical Incidents- Common Reactions**

Most common distortions of the traumatic event are:

- Distortion of time-(time sped up or slowed down)
- Sensory distortions- (i.e. tunnel vision, hearing changes, etc.)
- Perceptual or Behavioral Distortions- (i.e. Objects change size)
- Sense of helplessness-Limited choices
- “Fight/Flight/Freeze” response
- Disturbance in memory- sometimes our memory gives us “tunnel memory”
- Hyperarousal/Hypoarousal- heightened awareness of our surroundings or constriction of our perception
- Replaying the incident in your head (what ifs)

After a trauma an individual may feel:

After traumatic incidents individuals may exhibit increased emotions/bodily sensations such as:



Dear Neighbors,

The events on the Fourth of July were unfathomable, and on behalf of the Village, I would like to extend my deepest sympathies to our neighbors in Highland Park and all who were directly impacted by the violence on that day. Many lives were forever changed by the malicious and violent act of the perpetrator. The first responders, local officials, doctors, nurses, other healthcare workers, friends, and volunteers who responded to the chaos and devastation are the heroes here, and while there is nothing any of us can say or do to change the outcome of the day's events, we can be thankful for the efforts of the many who responded to the scene, captured the suspect, assisted the wounded, and comforted those who lost friends and family members.

In the Village, we will be having ongoing conversations about safety at our public events on top of those already existing to help protect our schools, our

library, our events, and our other public institutions. We will have more to say in the coming weeks and months about steps you can take to keep your family and other members of our community safe. I know that firearm safety and secure gun storage is a topic of interest, and one the Village will be discussing more in the coming days.

If you have not already, please sign up for [Smart911](#). While 911 dispatch centers have information about your mobile phone's general location, Smart911 is a secure system that provides 911 dispatchers with more detailed information about you that can be of great importance in the event of an emergency. In addition, Smart911 allows the Village to contact you in the event of an emergency. Your personal information is not shared with the Village when you opt in to this system. You must update your security profile every 6 months to maintain an active profile on the service, which will allow you to receive emergency updates from the Village, should we need to send them.

The city of Highland Park is keeping a list of events and service opportunities posted by Mayor Rotering, [found here](#), should you want to contribute to their recovery efforts. The [Lake County Community Foundation](#) also has opportunities give back.

It is important after an event like this one to discuss mental health. Should you have a friend or family member whose wellness is a cause for concern, please do not wait to take action. Too often, we think that our problems are not big enough to warrant attention, but it is far better to address situations that can be remedied before they spiral out of control. Additionally, do not hesitate to call 911 if you find yourself in a situation in which you feel unsafe. If you are unsure of what resources you may have, the Winnetka Police Department has a social worker who can assist you.

There are not adequate words to express the shock, sadness, and dismay about the events of July 4. I would like to echo the statements of support I have seen from other local leaders for our Highland Park neighbors. Our community

is stronger when we come together to support one another, and I encourage you to continue to provide care and assistance to those in need, as we help Highland Park process and recover.



