





As per our discussion this morning- I know hands down that there are two agencies that are great and could start providing services for our officers sooner than later. I know that after 2 "sleep cycles" 48 hours- its critical to get services started . at least debriefing -

Northern IL CISM - Critical Incident Stress Management

I've trained with them, they have a great model and have an amazing team with police and fire personnel. They already came out I believe on the fourth or following to provide debriefing for HPPD dispatch. They indicated that all you have to do is call the 800 number and indicate that you are Highland Park Police- other local departments have already been using them (I think Lake Forest PD just used them). I have a pamphlet in my office on the wall-feel free to grab it- or click here: <u>http://www.ni-cism.org/index.html</u> Also- they are FREE!!!

First Responder Wellness Center:

This is a great organization- I have met and spoken to the founder Dr. Steiner several times over as she is a 13 year vet of CPD before switching over to mental health and dedicated herself to helping first responders. I have referred several public safety employees throughout the years –and they've been grateful.

They do Debriefings as well as individual/group therapy, crisis and exposure therapy. She also offers to come out to PD's and speak/present about their services which I think is great. She came out to Winnetka PD, and we saw her in alternating shift/groups- I kid you not, when I say initially everyone was not thrilled for having to sit in during presentation of services, but after her presentation- SEVERAL stopped to ask her questions and had a complete different perception of services afterward- SO WORTH IT!!! I HIGHLY HIGHLY Recommend.
