The below photo is time stamped at 11:52 AM - details included in picture attached. It's very suspect to me that he would be wandering this area at this time with no mention of it in any of his interviews. I can tell you first hand this is him and even though it's his back I trust you can cross time it with the camera on the gas station to see his face. After losing a mayoral race and having his business shuttered I believe he has motive as well. I implore you to look further into him. Something isnt adding up here and you guys need this information.
